A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE MONROE COUNTY COMMERCIAL FISHERMEN, INC. TO CONDUCT THEIR 14TH ANNUAL FLORIDA KEYS SEAFOOD FESTIVAL AT BAYVIEW PARK INCLUDING THE SOFTBALL FIELDS ON SATURDAY, JANUARY 19TH, 2019 FROM 11:00 A.M. TO 8:00 P.M. AND SUNDAY, JANUARY 20TH, 2019 FROM 11:00 A.M. TO 5:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Monroe County Commercial Fishermen Inc. has pledged that a 100 percentage of the monies raised at this event will go toward scholarships to be awarded to the children of fishermen or his/her family who excel academically.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West Florida;

SECTION 1. That the Monroe County Commercial Fishermen's, Inc is hereby granted permission to conduct a Seafood Festival on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meets the terms and conditions set forth by the City Manager

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, the Monroe County Commercial Fishermen, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 3. That the Monroe County Fishermen, Inc will adhere to the recycling plan of the City of Key West, and that (1) recycling container for every one (1) trash barrels will be

used and that they will be placed side by side.

SECTION 4. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
