**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ADJUSTING THE FEE FOR APPLYING FOR A TEMPORARY WAIVER OF THE NOISE CONTROL ORDINANCE TO \$75.00, PURSUANT TO SECTION 26-199(c) OF THE CODE OF ORDINANCES; PROVIDING FOR ANNUAL FEE ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the fee for a temporary waiver application for an exemption to the noise ordinance was established more than 20 years ago, and has not been adjusted; and

WHEREAS, Section 26-199(c) of the Code of Ordinances provides that "the city commission may charge the applicant a fee established by resolution of the city commission to cover expenses resulting from the processing of the permit of temporary waiver application;" and

WHEREAS, application processing costs have increased, and City staff recommends approval of a fee adjustment, along with approval of a provision to ensure annual fee adjustments; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the fee for an application for a temporary waiver of noise/sound control ordinance shall be \$75.00, to become effective for applications received on or after the effective date of this Resolution.

Section 2: That the fee for an application for a temporary waiver of noise/sound control ordinances shall increase by 5% annually, to become effective on October 1, 2020, and each year thereafter, until or unless amended by Resolution of the City Commission.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
