

RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING INTEGRITY SPORTS, INC. TO CONDUCT THE ANNUAL KEY WEST TRIATHLON FROM THE COLLEGE OF THE FLORIDA KEYS, USING ONLY COLLEGE ROAD ONTO THE OVERSEAS HIGHWAY EASTBOUND AND BACK, ON SUNDAY, DECEMBER 10, 2023 FROM 4:00 A.M. TO 12:00 NOON; COLLEGE ROAD WILL REMAIN OPEN AND OPERATE AS NORMAL AND IS THE ONLY PART OF THE COURSE WITHIN CITY LIMITS OF KEY WEST; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Integrity Multisport, Inc. wishes to conduct their Annual Key West Triathlon at the College of the Florida Keys” between the hours of 4:00 a.m. to noon Sunday, December 10, 2023; and

WHEREAS this events course will utilize college road only during the hours of 4:00 a.m. to noon on December 10, 2023.

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law”

SECTION 2. “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor

therefore, commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the City”

SECTION 3. That Integrity Multisport Inc. is hereby granted permission to conduct their annual “Key West Triathlon” on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 4. That Integrity Multisport, Inc. acknowledges that they are responsible for payment to the Key West Police Department for their services on College Road.

SECTION 5. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
