**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AMENDING THE CONTRACT FOR ENVIRONMENTAL ENGINEERING SERVICES WITH E SCIENCES, INCORPORATED BY AMENDING THE CONTRACT TO REFLECT A NAME CHANGE TO RESOURCE ENVIRONMENTAL SOLUTIONS, LLC (RES); PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, in Resolution No.20-039, the City Commission approved a three-year contract with E Sciences (and three other vendors) for Environmental Engineering Services; and

WHEREAS, effective January 27, 2022, E Sciences changed its name to Resource Environmental Solutions, LLC, dba E Sciences, when it became a wholly owned subsidiary of RES; and

WHEREAS, work will continue to be conducted by trusted E Sciences staff, and accordingly staff recommends approval of this corporate name change; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby consents to amend the City's Environmental Engineering Services Contract with E Sciences, Incorporated to reflect a name change to Resource Environmental Solutions, LLC for the remaining term of the contracts, including the two-year extension set forth in a concurrent resolution.

Section 2: That the City Manager is hereby authorized to execute any necessary Consent to Amend the contract with E Sciences to reflect the new name of Resource Environmental Solutions, LLC (RES), upon advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
