An application was received requesting the removal of **(1) Royal Poinciana tree**. A site inspection was done on January 16, 2018 and documented the following:

Tree Species: Royal Poinciana (Delonix regia)



Strangler Fig tree to be trimmed.

Diameter: 13"

Location: 50% (growth impacted by canopy of strangler fig tree and house-growth heavy lean-seeking the sun)

Species: 100% (on protected tree list)

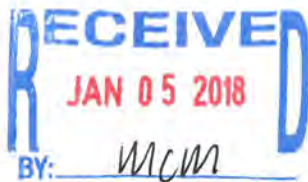
Condition: 40% (poor, co-dominant trunks, long leggy trunks with strong lean, root structure growth is lifted with several voids)

Total Average Value = 63%

Value x Diameter = 8.1 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Royal Poinciana tree at 218-220 Simonton Street to be replaced with 8.1 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

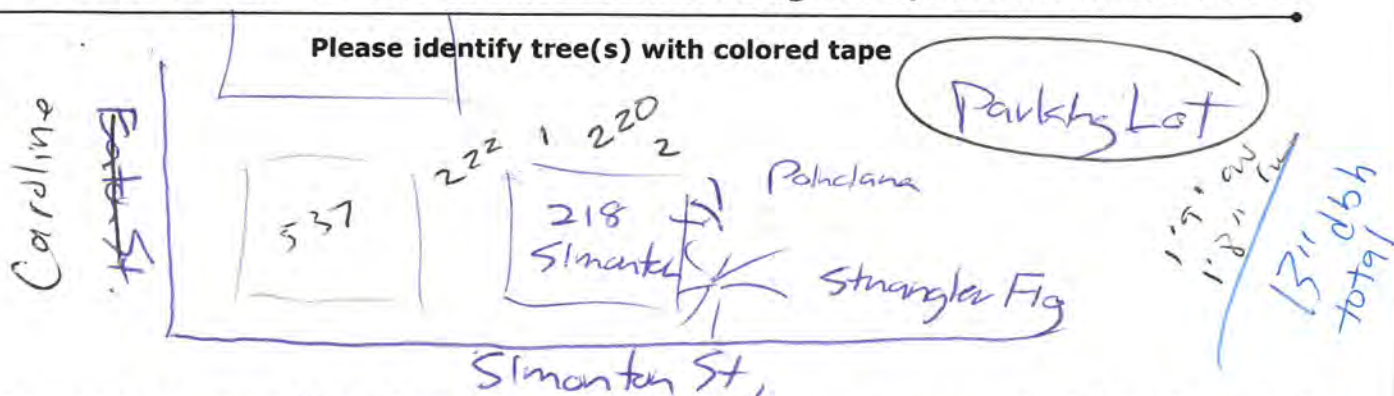
