A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF CSCAPE CONSTRUCTION, INC. FOR KEY WEST MOORING FIELD INSPECTION AND GROUND TACKLE REPLACEMENT FOR A CONTRACT TERM OF THREE YEARS IN RESPONSE TO INVITATION TO BID (ITB) #23-009; AUTHORIZING ONE INSPECTION AND REPLACEMENT (\$83,936.60) IN FY 22/23 AND TWO INSPECTIONS AND REPLACEMENTS IN FY 23/24 AND SUBSEQUENT YEARS (\$167,873.20 PLUS ANNUAL CPI ADJUSTMENTS); AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS AND AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN CONFORMANCE WITH THE BID DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, two bids were opened on April 19, 2023 in response to ITB #23-009, for mooring field inspection and rig replacement, for a term of three years, with CScape Construction, Inc. submitting the lowest responsive bid; and

WHEREAS, City staff finds the lowest bid to be responsive and responsible, and recommends award of the bid to CScape Construction, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION  
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of CScape Construction, Inc.  
is hereby awarded in response to ITB 23-009 for Mooring Field  
Inspections & Ground Tackle Replacement.

Section 2: That in FY 22/23 one inspection/  
replacement is authorized in an amount of \$83,936.60. Two  
inspection/replacements are authorized for each remaining  
years of the contract, at an anticipated annual cost of  
\$167,873.20 plus applicable annual CPI adjustments.

Section 3: The inspections and ground tackle project  
is partially funded in accounts 413-7554-575-3400  
(inspections) and 413-7554-575-4600 (ground tackle). A budget  
transfer for FY 22/23 in the amount of \$50,000.00 is hereby  
authorized from reserves to Ground Tackle account 413-7554-  
575-4600. Any related budget amendments or adjustments are  
hereby authorized.

Section 4: That the City Manager is hereby authorized to execute a contract in substantial conformance with the bid documents upon consent of the City Attorney.

Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
