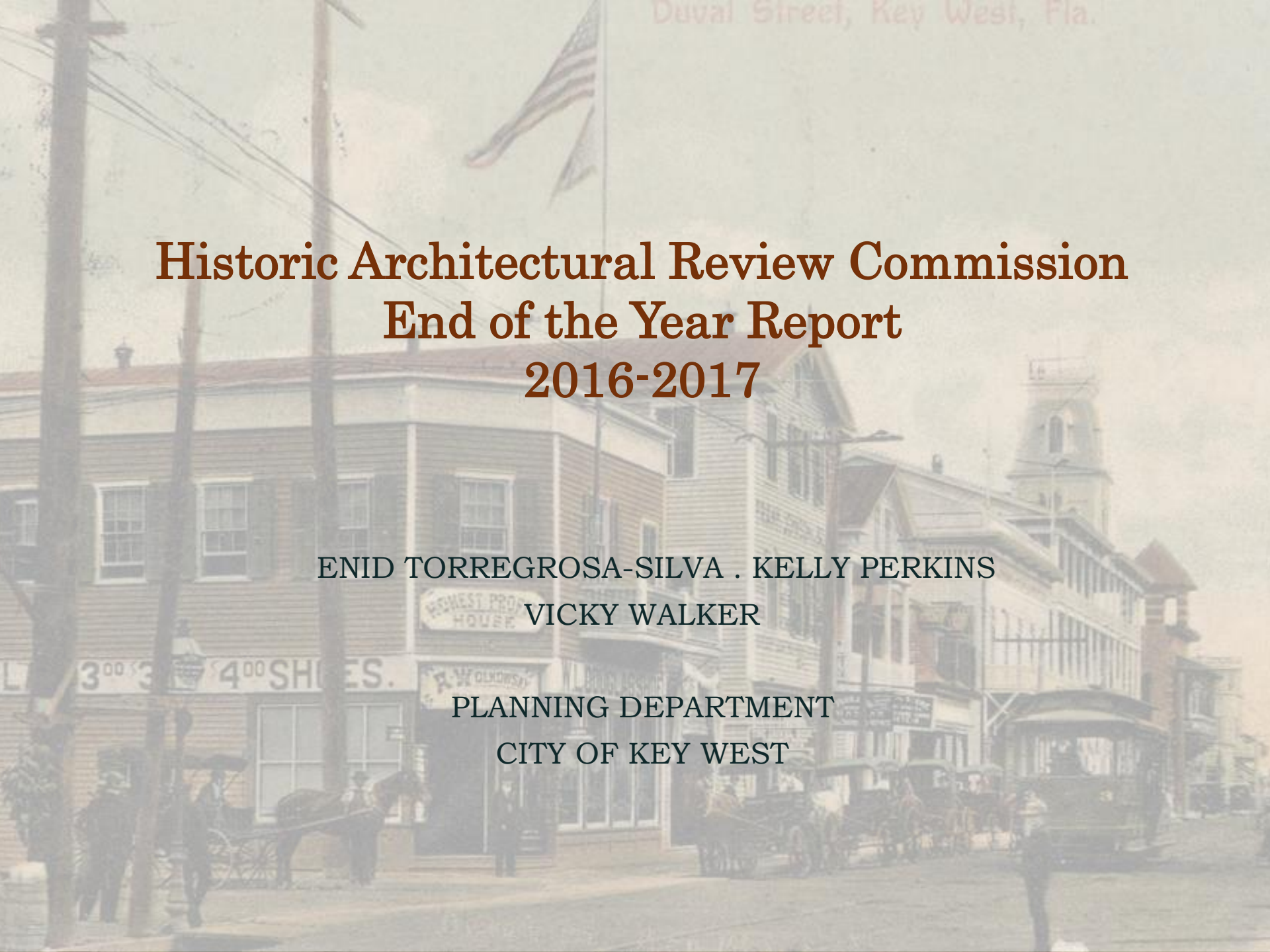

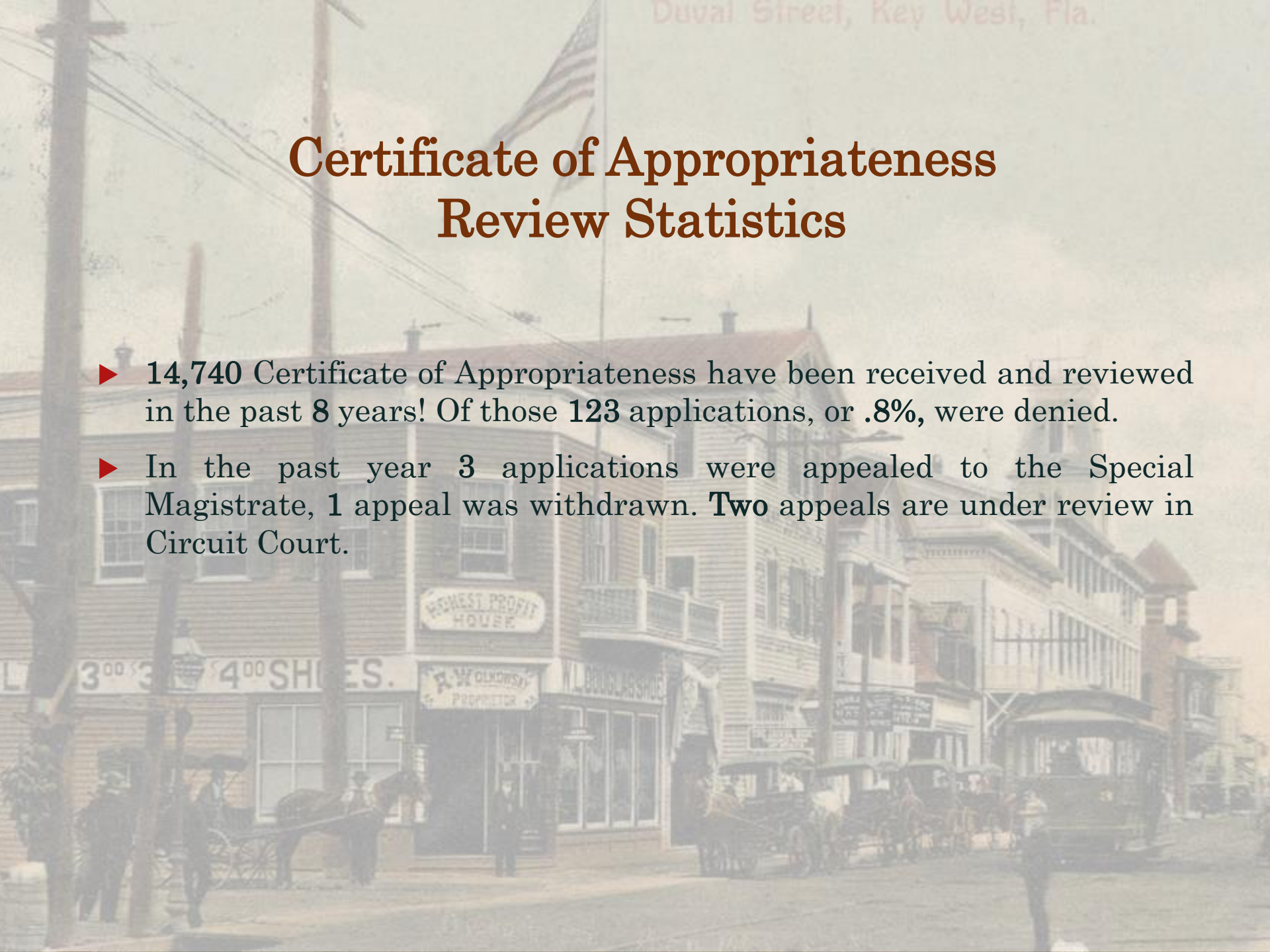

Certificate of Appropriateness Review Statistics

- ▶ In 2016-2017 Fiscal Year Staff approved **1,516** Certificates of Appropriateness or **93%** of received applications.
- ▶ During the Fiscal Year HARC held **11** public meetings. Staff prepared reports and packages for all public meetings.
- ▶ During the 2016-2017 Fiscal Year the Commission reviewed **84** applications, **65** of those applications were approved and **13** were denied, and **13** were withdrawn or postponed.
- ▶ In 2016-2017 Fiscal Year HARC collected **\$234,860** in applications, reviews, inspections, and fines fees.
- ▶ During 2016-2017 Fiscal Year there was a decrease in Certificates of Appropriateness if compare to 2015-2016 Fiscal Year (**341 less applications**).

Certificate of Appropriateness Review Statistics

- ▶ 14,740 Certificate of Appropriateness have been received and reviewed in the past 8 years! Of those 123 applications, or .8%, were denied.
- ▶ In the past year 3 applications were appealed to the Special Magistrate, 1 appeal was withdrawn. Two appeals are under review in Circuit Court.
