An application was received requesting the removal of **(1) Strangler Fig tree**. A site inspection was done and documented the following:

Tree Species: Strangler Fig (*Ficus aurea*)



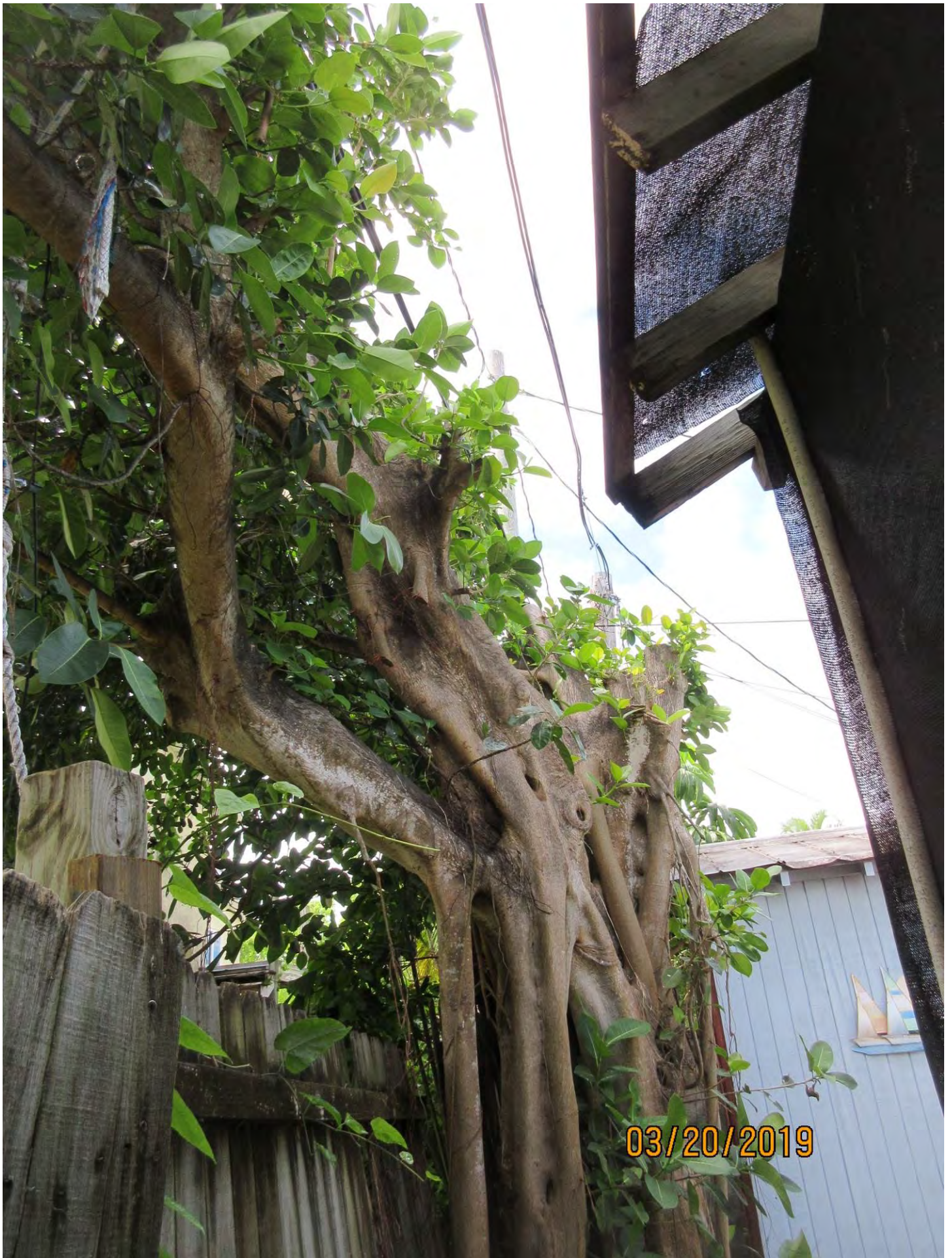

Diameter: 38.2"

Location: 60% (growing under utility lines on fence line)

Species: 100% (on protected tree list)

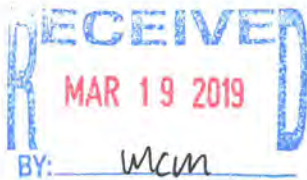
Condition: 40% (poor, one sided canopy due to constant utility line trimming, multi trunked/aerial root trunks, wrong tree-wrong place.)

Total Average Value = 66%

Value x Diameter = 25.2 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Strangler Fig tree at 2816 Harris Avenue to be replaced with 25.2 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

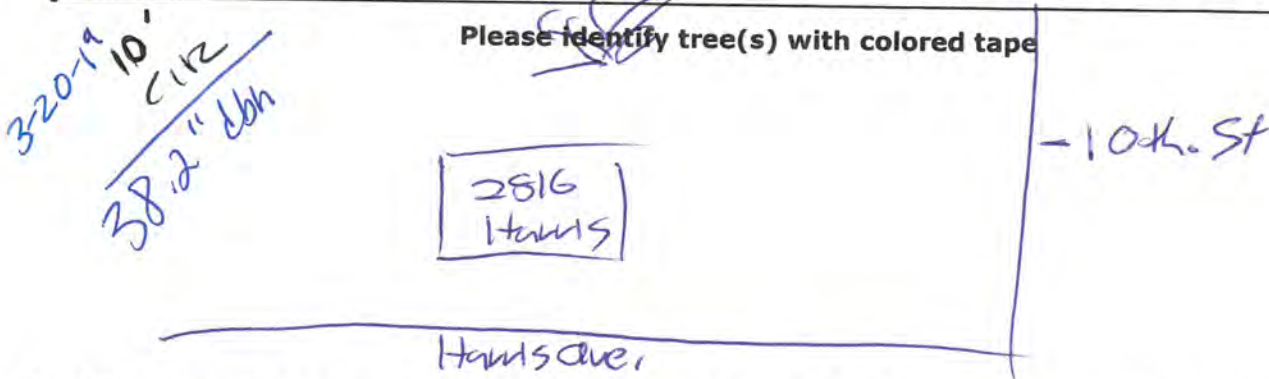

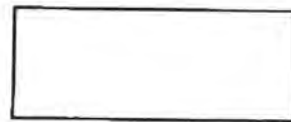
