Commissioners,

Throughout the cruise ships deliberations little has been said about the elephant in the room: the relationship between yourselves and the City Attorney. Many months ago you assigned the City Attorney to write an ordinance. He persuaded the Commission that he couldn't compose an ordinance himself and he needed outside counsel to do that. When finally engaged at great cost, the outside attorney persuaded you that writing an ordinance wasn't the whole job. There needed to be negotiations with the Walsh company, purportedly to seek concessions. The outside attorney's brief was expanded to include meetings with the Walsh company.

The City Attorney and the outside attorney proceeded to negotiate, without oversight by any commissioners. You delegated total authority to the City Attorney and did not observe, participate in or supervise the negotiations. You appeared to *many* citizens of Key West to be too intimidated and too cowed by the City Attorney to demand faster results, to ask questions that called out for answers or to do anything but thank him for his efforts. WHY? He was clearly not trying to accomplish what the voters of Key West mandated. Why did he have license to countermand your directions? Who supervised him?

The negotiations have led to a proposal that is a pure give-away, to the great detriment of the City. How long has this "deal" been in the works? How could the Commission have arrived at a

point where you are about to vote on such a resolution? Who presented it for a vote? It reeks of corruption.

Citizens who care about the waters and reefs of Key West know we've been HAD, by the City Attorney, who has purposely taken us from an assignment to write an ordinance codifying referenda, to a BETRAYAL of its very purpose.

Please reject the development proposal. Dismiss the City Attorney - or if you are powerless to do so due to the contract he wrote for himself - remove him from all work assignments on this critical issue.

Dear Mayor and Commissioners,

I wish I could say that I was shocked to read the contents of the new “compromise” being offered to and by Pier B. After a dishonest and vicious dark money campaign, Mr. Walsh’s attempting to stifle the vote count, and \$1,000,000 “donation” to Governor Preemption the fact that someone would actually have the nerve to offer this document to the Commission should have been shocking but actually seemed like more of the same roadblocks the voters have encountered since the referendum’s successful passage. This contract is a slap in the face to the voters of Key West. Who negotiated this agreement which appears to be a complete giveaway and why? I hope the motivation for the city’s negotiators giving away the store was born out of ineptitude and not malice. The optics are disturbing.

I was originally left wondering why Pier B would renegotiate a contract described as inviolate and worthy of a \$100,000,000 judgement against the city. After the decision of a judge we can get a true reading of our situation and what to negotiate going forward. As our representatives I know that you are probably equally flummoxed by what has been offered and will act in what the voters and citizens of Key West has indicated is the direction that they would like to see Key West go. A sustainable home both culturally and environmentally and politics that reflect the will of all the people and not just the few.

About 2 years ago I voted on 3 referendums concerning the Cruise Ships that visited Key West. I fully supported the Safer, Cleaner Ships group throughout the process in hopes that Key West would end up with a balance for everyone concerned. Then the governor signed legislation that overrode our votes and the process started over.

I hoped that some type of compromise could be reached, especially with the Pier B group, but most of that was done behind closed doors and the general public was not aware of the details of any potential compromise until about 2 weeks ago. I have reviewed the proposed compromise and find it very lopsided in favor of the Pier B owners. I am writing this note to each of you to express my dissatisfaction with the proposal put forth that will be reviewed (and voted on??) this Tuesday April 5.

In the meantime, I have received a message from the Safer, Cleaner Ships group detailing a legal memorandum that was submitted to all of you. I have reviewed the legal document and it appears that there is a case made that might prevent the proposed agreement in favor of a more balanced approach.

I am very surprised and disappointed that our City Attorney, who is supposed to be representing the people, was not able to find this same information by reviewing all of the previous agreements and their application to the matter at hand.
