A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING TASK ORDER TO-2-23 FOR JACOBS ENGINEERING GROUP, INC. IN AN AMOUNT NOT TO EXCEED \$154,934.50 TO PREPARE PHASE 1-SEWER COLLECTION SYSTEM MASTER PLAN; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 23-029, the City Commission approved a contract Jacobs Engineering Group, Inc. for General Engineering Services on a task-order basis; and

WHEREAS, the City entered into Consent Order OGC 21-0581 with the State of Florida Department of Environmental Protection (FDEP), which outlines required measures to correct deficiencies in the sanitary sewer system; and

WHEREAS, a Sewer Master Plan will inform capital improvement needs, and meet FDEP requirements to develop an Inflow and Infiltration Plan (I&I) and Lift Station Plan to help mitigate flow into the system from groundwater and stormwater; and

WHEREAS, due to time-sensitive provisions of the Consent Order, the first phase of the Master Plan will primarily include the I & I Plan and Lift Station Plan, and

the second phase of the plan will include a condition assessment, project priorities, cost estimates and a five-year project schedule; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Task Order TO-2-23 from Jacobs Engineering Group, Inc. for Phase 1 - Sewer Collection System Master Plan Development is hereby approved in an amount not to exceed \$154,934.50.

Section 2: That this project is budgeted in Sewer/Renewal and Replacement Account No. 401-3503-535-6500, and any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.
