A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF D.L. PORTER CONSTRUCTORS, INC. FOR CABLE HUT STABILIZATION AND REPAIR, IN ACCORDANCE WITH THE TERMS SPECIFIED IN ITB #21-001, IN AN AMOUNT NOT TO EXCEED \$317,421.30, INCLUSIVE OF SPECIFIED DEDUCT ALTERNATES, AND 5% OWNER CONTINGENCY OF \$15,115.30; AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN THE BID PACKAGE UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND AMENDMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on October 28, 2020, three responsive bids were opened in response to ITB #21-001 for Cable Hut Stabilization and Repair, and upon staff review and consideration of bid alternates, it was recommended that the contract be awarded to D.L. Porter Constructors, Inc. as the lowest cost responsive and responsible bid; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of D.L. Porter Constructors, Inc. for Cable Hut Stabilization and Repair, in accordance with the terms specified in ITB #21-001 inclusive of specified deduct alternates and a 5% contingency fund, is hereby awarded in an amount not to exceed \$317,412.30.

Section 2: That the City Manager is authorized to execute a contract in substantial conformance with the bid documents, upon the advice and consent of the City Attorney.

Section 3: That funds for the project are allocated in account #101-4302-543-6300, Project #IS43022001. Any necessary budget transfers or amendments are hereby authorized.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
