 The infrastructure and scale of old town Key West is not compatible with the arrival of 6,000 cruise ship visitors











## Florida Keys National Marine Sanctuary Attracts Tourists

- Each year
  - 400,000 visitors & residents participate in sports fishing
  - 700,000 enjoy diving and snorkeling
  - Over 30,000 Monroe County jobs are supported by ocean recreation and tourism
  - 70% of tourists arriving by auto and 76% arriving by air participate in some water based activity

## Sanctuary Condition Report November 2011



- Water Quality
  - Fair / Poor
- Habitat / Coral Reef
  - Fair / Poor
- Sustainable Fishing / Biodiversity
  - Fair / Poor



### Key West Harbor Reconnaissance Report

- Environmental Impacts
  - Significant Negative Impact on Environmental Quality
  - Significant and Negative effect on unspecified quantity of coral
  - Negative impact on unspecified amount of critical environmental habitat
  - Likely increase in water pollution and turbidity



# Federal Laws Establish Sanctuary Protection

- Public Law 101-605 lists prohibited activities in the sanctuary including
  - ". . . drilling into, dredging or otherwise altering the seabed of the Sanctuary (Florida Keys National Marine Sanctuary)."
- Any weakening of sanctuary rules could threaten not only the Florida Keys, but other sanctuaries spread through the USA

# Reconnaissance Report Issue with the Feasibility Study

"Congressional action is needed prior to any construction activity within the boundaries of the Florida Keys National Marine Sanctuary. Until this issue is resolved there is little benefit in proceeding with the feasibility phase."



### Feasibility Study Costs

- Can a Feasibility Study be done without cost to Key West taxpayers?
  - 50% Federal share is paid from income taxes Key West residents & businesses pay
  - Cruise Lines visiting Key West are exempt from U.S. Federal income tax
    - Carnival Corporation reported \$0 U.S. Federal tax on 2011 pre-tax earnings of \$1.9 billion
    - Royal Caribbean Cruises reported \$0 U.S. Federal tax on 2011 pre-tax earnings of \$931 million



### Feasibility Study Costs

- Can a Feasibility Study be done without cost to Key West taxpayers?
  - Significant staff time will be required to find funding and lobby for Federal laws

 General Fund revenue pays Key West Federal lobbyists Alcalde & Fay





#### Cruise Line Trends

- Key West has fewer port calls scheduled for 2013 – is channel width the issue?
- What could the replacement ships look like if the channel is dredged?



## Future Overcrowding?

- 7,858 Visitors
  - Royal Caribbean Freedom Class Vessel
    - 3,561 Passengers
    - 340 Crew
  - Carnival Magic
    - 3,616 Passengers
    - 341 Crew



98% Passenger Capacity, 25% of Crew

#### Conclusions - Environment

- Florida Keys National Marine Sanctuary condition is a concern
- Channel Dredging environmental impacts to critical marine habitat, coral and water quality are negative
- Public Law 101-605 protects the FKNMS from new dredging



#### Conclusions – Economics

- Tourists arriving by air spend over 3 times the daily spending of cruise ship passengers
- Conducting a feasibility study at no cost to the Key West taxpayers will be difficult
- Declining cruise ship calls, at least in 2013, do not appear to be related to channel width
- Replacement ships may bring 32% more passengers
