-- Jeremiah Andrew Shumate Arrest Narrative:

On Thursday, 05/05/2022 at approximately 2127 hours, Ofc. Hernandez and I (Ofc. Howell) completed an area check of 800 Caroline Street (Key West Bight Parking Lot, Private Parking) and discovered several unknown male subjects possibly trespassing.

Four of the unknown male subjects complied, followed basic instructions, provided forms of identification, and walked away after I issued their trespass warnings. One unknown white male subject who refused to comply several times and continuously remained in the immediate area after I explained he needed to leave at least five times, later identified as Jeremiah A. Shumate (DOB: 05/10/1995, Arrestee). Shumate who was laying within the bushes and bike rack on the property of the private lot, near the Margaret Street side of the business with the other five unknown male subjects. Shumate initially refused to comply with basic instructions. Shumate eventually complied with my instructions. At this point, Ofc. Hernandez arrived as by back up. Ofc. Hernandez and I provided the other four male subjects with trespass warnings and moved them along. Shumate continuously ignored my legal, lawful orders to leave the immediate premises. As I placed Shumate in handcuffs, he attempted to pull away several times. I gave Shumate several loud, concise verbal commands to stop pulling away. I was eventually able to gain control to Shumate and place him in handcuffs.

Ofc. Hernandez searched Shumate subsequent to arrest. Ofc. Hernandez walked Shumate to my patrol vehicle. During Ofc. Hernandez search, Shumate continuously attempted to pull away from Hernandez.

Shumate remained argumentative while I attempted to provide him with warning regarding other city ordinances. Shumate continuously screamed obscenities toward me.

I transported Shumate to the Monroe County Detention Center. Shumate continuously yelled obscenities throughout the transport.

Based on the facts and evidence, I believe there is probable cause that on 05/05/2022, Jeremiah A. Shumate did knowingly and intentionally violate F.S.S. 843.02 Resisting without Violence, by actually and intentionally attempting to pull away from the me as while I placed him in handcuffs, while I was engaged in my legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on 05/05/2022, Jeremiah A. Shumate did knowingly and intentionally F.S.S. 810.09-1A1 Trespass on Property Other Than Structure or Conveyance, by actually and intentionally remaining on the premises and refusing to leave the property, after being warned several times.

My BWC was activated for the encounter, arrest, and subsequent search of Shumate. My FLEET AXON was activated for the transport of Shumate to Monroe County Detention Center. I uploaded the videos to Evidence.com.

At this time, no further information.

Shumate remained argumentative as I removed him from my patrol vehicle and attempted to pull away from me several times. I instructed him with stop attempting to face me, Shumate replied, "NO I should spit on you." Shumate immediately became aggressive and suddenly and swiftly began attempting to pull away from me and refused to comply with my legal, lawful orders to "stop trying to turn around." Due to Shumate's actions, continuous threats, and level of resistance rising I shoved Shumate's shoulders into the corner of the elevator in a controlled manner to prevent him from spitting on me. Shumate continued to attempt to turn his head toward as if he intended to follow through with his threats of spitting on me. I placed my left hand on the back of Shumate's head to prevent him from turning toward me, for approximately thirty seconds for the remainder of the elevator ride. Shumate continuously screamed obscenities toward me.

I continued to walk Shumate to the Monroe County Detention Center. Shumate continuously yelled obscenities throughout the elevator ride. Shumate's actions were so aggressive that Monroe County Detention Deputies initially refused to remove Shumate's handcuffs until he calmed down. Shumate remained in handcuffs until he was medically cleared.

Due to Shumate's actions and resistance, he received a small half inch laceration above his left eyebrow. Shumate was
