A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE FOR THE FIRE DEPARTMENT OF ONE (1) 2022 WHEELED COACH/FORD F550 AMBULANCE PLUS ACCESSORIES FROM MATHENY FIRE AND EMERGENCY, PURSUANT TO GOVERNMENT CONTRACT (FL SHERIFFS' ASSOCIATION/FL ASSOCIATION OF COUNTIES CONTRACT FSA 23-VEF17.0), PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES IN A TOTAL AMOUNT NOT TO EXCEED \$358,919.00; AUTHORIZING NECESSARY BUDGET TRANSFERS AND ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City Fire Department administrative staff has identified a vendor that is willing and able to provide an ambulance as soon as August 2024, and therefore recommends the purchase of one new 2022 Wheeled Coach/Ford F550 Ambulance from Matheny Fire and Emergency, Inc., under the Florida Sheriff's Association, and the Florida Association of Counties Bid No. FSA23-VEF17.0, pursuant to section 2-797(3) of the Code of Ordinances; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one (1) 2022 Wheeled Coach/Ford F550 Ambulance plus accessories in a total amount not to exceed \$358,919.00, from Matheny Fire and Emergency, pursuant

to government contract, pursuant to section 2-797(3) of the code of ordinances, is hereby approved.

Section 2: That \$337,334 was budgeted in account Infrastructure/Surtax/EMS 101-2601-526-6400 for this FY22-23 ambulance purchase. A budget transfer of up to \$21,585 from Infrastructure Surtax Reserve Fund 101-1900-519-9803 to Infrastructure/Surtax/EMS 101-2601-526-6400 is hereby authorized to fully fund and complete the purchase.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
