A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "PUBLIC TRANSPORTATION JOINT PARTICIPATION AGREEMENT" (JPA) BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR DISTRICT DISCRETIONARY REVENUE FUNDS THROUGH THE STATE TRANSIT CORRIDOR PROGRAM FOR THE CITY OF KEY WEST DEPARTMENT OF TRANSPORTATION TO PURCHASE UP TO FIVE (5) BUS ENGINES, DRIVE-TRAINS AND RELATED PARTS IN AN AMOUNT NOT TO EXCEED \$100,000.00 (CONTRACT #ARJ40); AUTHORIZING THE CITY MANAGER AND/OR TRANSIT DIRECTOR TO EXECUTE NECESSARY DOCUMENTS AND NECESSARY BUDGET AMENDMENTS; PROVIDING AN EFFECTIVE DATE;

WHEREAS, funding through the FDOT District Discretionary Revenue Funds, may provide assistance for capital expenses of transit system buses;

WHEREAS, in Resolution 13-260, the City Commission authorized certain members of City staff to apply for and accept grant funding, and to execute and submit grant documentation through the Transportation Electronic Award Management System and Florida Department of Transportation; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Public Transportation Joint Participation Agreement" (Contract #ARJ30) is hereby approved, between FDOT and the City, for District Discretionary Revenue (DDR) Funds through the State Transit Corridor Program for the City of Key West DOT to purchase up to five (5) bus engines, drive-trains and related parts in an amount not to exceed \$100,000.00.

Section 2: That the City Manager is authorized to effectuate any necessary budget transfers in accordance with such grant agreement, and to execute any necessary documents.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
