**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING "AMENDMENT (3<sup>rd</sup> AMENDMENT) TO AGREEMENT" ID #2985 TO EXTEND THE TERMINATION DATE TO DECEMBER 31, 2027 FOR TOURIST DEVELOPMENT COUNCIL FUNDING OF THE SOUTHERNMOST PLAZA (PUBLIC FACILITIES) PROJECT; AUTHORIZING THE MAYOR TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, in Resolution 23-238 the City of Key West accepted a Grant Award from the Tourist Development Council to assist with a tourism impact study and with improving and enhancing the area near the Southernmost Point buoy on South Street from Duval Street to the intersection at Whitehead Street (Agreement ID #2985); and

WHEREAS, in Resolution 24-076 the City of Key West approved the 1<sup>st</sup> Amendment to Agreement ID #2985, a no-cost time extension to September 30, 2025; and

WHEREAS, in Resolution 25-183 the City of Key West approved the 2<sup>ND</sup> Amendment to Agreement ID #2985, a no-cost time extension to September 30, 2026; and

WHEREAS, City staff recommends ratifying the attached 3<sup>RD</sup> Amendment to Agreement ID #2985, which grants no-cost time extension for the project to December 31, 2027; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Amendment (3<sup>rd</sup> Amendment) to Agreement" ID #2985, to extend the termination date for the Southernmost Plaza (Public Facilities) project to December 31, 2027, is hereby approved.

Section 2: That the Mayor is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
