



NARRATIVE OF INCIDENT

Willis refused to follow verbal commands and continued approaching Officer Golovanov while he was attempting to interview the victim. Willis was placed in handcuffs and told to sit down so Officer Golovanov could continue his investigation. Willis refused to comply with Officer Golovanov's

commands. Officer Golovanov began walking Willis to his patrol car, where he would be detained pending the results of the investigation. Willis pulled away, breaking Officer Golovanov's grip, turned around and faced off with Officer Golovanov. Officer Golovanov retrieved his TASER and displayed it in the direction of Willis. Willis continued to resist and was drive stunned on his upper, left shoulder.
