A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF KIEWIT INFRASTRUCTURE SOUTH CO. (KIEWIT) IN RESPONSE TO ITB #18-029 IN A TOTAL AMOUNT NOT TO EXCEED \$336,750.00, FOR EDWARD B. KNIGHT PIER SPAN 1 DECK REPLACEMENT; AUTHORIZING NECESSARY BUDGET TRANSFERS AND AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, two responsive bids were opened on July 11, 2018, 2018, in response to ITB #18-029, and City staff recommends award of bid to the lowest responsive bidder; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of Kiewit Infrastructure South Co. is hereby awarded in an amount not to exceed \$336,750.00, as set forth in the response to ITB #18-029, for Edward B. Knight Pier Span 1 Deck Replacement, the terms and conditions of which are incorporated herein.

Section 2: That funding of this project is anticipated upon adoption of the FY 18/19 Budget, effective October 1, 2018, under account 101-7201-572-6300 - Project #IS72011801, and any necessary transfers are authorized. The contractor has agreed to hold bid for 90 days (until October 9, 2018).

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney, that are consistent with ITB #18-029 and the approval granted herein.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
