Last night at the Tree Commission meeting, our attorney, Eric Nordback, mentioned that we had a request to rehear the application to remove the Gumbo Limbo tree at 620 Thomas St #172. The Tree Commission denied the request at the May 2023 meeting. The property owner has since removed several boards, took photos, and had an arborist look at the situation (see attached). Instead of waiting until the denial expires in November, he is asking to be heard sooner. To have the application reheard requires a resolution supported by a Tree Commissioner. This is the same procedure we did with the 12 Hilton Haven Dr application regarding the removal of the strangler Fig tree.

Please let me know by July 28, 2023, if you would like to support the resolution so I can place the resolution on the agenda for a vote at the August 2023 Tree Commission meeting agenda. If the resolution passes, then the application will be reheard at the September Tree Commission meeting.

I have received your email with attachments. City code section 110-322 states that if the application for a tree removal permit is disapproved, the applicant may modify and resubmit the application only after six (6) months from the date of the denial. Therefore, we would be looking at putting this on the November 13, 2023 Tree Commission agenda.

I would need to speak with legal as to whether this could be placed on an agenda sooner. Sometimes, files can be put on an earlier agenda if significant, additional, information is provided. I know the root issues was discussed at the Tree Commission meeting but I do not know if the discussion and this additional information would allow for this to be placed on an earlier agenda.
