A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "PUBLIC TRANSPORTATION GRANT AGREEMENT" (PTGA) BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR STATE FISCAL YEAR (SFY)2026 FTA SECTION 5311 RURAL OPERATING GRANT TO PROVIDE BUS SERVICES IN THE CITY OF KEY WEST, PTGA #G3H47/FINANCIAL PROJECT #434896-7-84-01 FTA SECTION 5311 RURAL OPERATING GRANT IN AN AMOUNT NOT TO EXCEED \$757,566.00; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 25-138, the City Commission authorized certain City staff to apply for grant funding and to execute and submit grant documentation through the Federal Transit Administration (FTA) and Florida Department of Transportation (FDOT); and

WHEREAS, the FTA Section 5311 Formula Grants for Rural Areas program provides capital, planning and operating assistance to states to support public transportation in rural areas with populations of less than 50,000, where many residents often rely on public transit to reach their destinations. This specific PTGA is for the operation of City routes; and

WHEREAS, Section 5311 Operating grant programs require a cost share of 50% FDOT and 50% City. The City could receive 50% reimbursement (up to \$757,566) of the maximum total operating expenses of \$1,515,132. The following local revenues have been identified as the required match for Section 5311 Rural Operating

grant: \$84,400 Bus Advertising; Other Charges: \$850; Park and Ride \$672,316;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Commission hereby approves the attached "Public Transportation Grant Agreement" (PTGA #G3H47/FM #434896-7-81-01) for Section 5311 Formula Grants for Rural Operations funds for bus services in the City of Key West for SFY 2026 between FDOT and the City of Key West, in an amount not to exceed \$757,566.00 (50% of the total project cost of \$1,515,132).

Section 2: That the City Manager is hereby authorized to execute any necessary related documents and budget transfers/amendments, project scope and extensions in accordance with such grant, upon consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
