

RESOLUTION NO. 19-328

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, TO ESTABLISH A POLICY REQUIRING THAT OPTIONS FOR SOLAR POWER COMPONENTS ARE PRESENTED TO THE CITY COMMISSION FOR ALL FUTURE CITY DEVELOPMENT AND REDEVELOPMENT PROJECTS; DIRECTING CITY STAFF TO PRESENT FEASIBILITY AND COST ESTIMATES FOR EACH CITY-INITIATED PROJECT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Commission recognizes that solar energy is an essential component of almost any Green or Clean energy plan in Key West; and

WHEREAS, the City Commission has previously embraced energy efficiency and greenhouse gas reduction programs, including Property Assessed Clean Energy (PACE), and Green Business Certifications as actions to reach the City Commission's community greenhouse gas reduction goals; and

WHEREAS, the City Commission seeks to reaffirm its commitment to clean energy, by establishing a policy to require the presentation of solar power component options for all future city construction, including new development and re-development projects.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF  
THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby  
establishes a policy to require that options be presented for  
solar power components for all future city redevelopment and  
development projects.

Section 2: That City staff is directed to present  
feasibility and cost estimates for each city-initiated  
project, for City Commission consideration.


Section 3: That this Resolution shall go into effect
