**Original Narrative By Dustin Christina, 03/26/26 04:12**

On 03/26/2026 at approximately 0036 hours, I was dispatched to 420 Applerouth Ln In regard to a battery.

Upon my arrival, I met with the following off-duty Key West Police officers: Patrol Officer Samuel Adorno, Sgt. Tiffini Miller and Lt. Jeffrey Dean, who stated the following. On 3/26/26 at approximately 0033 hours, they had exited Virgilio's onto Applerouth Ln when they observed a male, later identified as Hamza Yamani, striking a woman, identified as Adrianna A Flagg, with his closed fist in her face. They all yelled to stop to which Yamani ignored. At this point, Ofc. Adorno and Lt. Dean placed themselves between Yamani and Flagg while Sgt. Miller escorted Flagg away. In this process, Yamani began to swing at Flagg again, to which Ofc. Adorno delivered a counterstrike that incapacitated Yamani.

Sgt Miller stated that Flagg had run away, holding her face. It was later determined that Flagg lived in 534.5 Duval St. #5, where she was located and interviewed. Flagg stated that she had been walking down Duval St. when an unknown

man to her was screaming "Fuck the USA, Fuck America," to which she responded with "Free Israel". This angered Yamani to the point he approached her, punching her in the face multiple times as well as kicking her. This is when the off-duty officers intervened. It should be noted that there were clear signs of swelling on the left side of her face, cheek area, as well as bruising on her chest. Photos were taken and uploaded to [Evidence.com](https://evidence.com). She was transported to the Lower Keys Medical Center for further care.

EMS was called to the scene to check on Yamani's injuries, but he refused. Once in jail he requested to be seen, so he was transported to the Lower Keys Medical Center, where he was cleared for jail.

Yamani was transported to the Monroe County Detention Facility for booking.

Based on the facts and evidence, I believe there is probable cause that on 03/26/2026, Hamza Yamani did knowingly and intentionally violate F.S.S. 784.03 Battery, by actually and purposefully striking Adrianna A Flagg, against her will, placing her in fear of bodily harm, and creating injury.

Flagg was provided a victim rights brochure on scene.

My BWC and Fleet Axon were active for this encounter and transport.

## **Supplemental Narrative By Jorge Lopez, 03/26/26 05:06**

On March 26, 2026, at approximately 0034 hours, Keys West Communications advised a physical altercation that was reported near Mary Ellen's Bar located at 420 Appelrouth Lane. Key West Communications advised the altercation involved a male and female. Key West Communications provided the following descriptions for the parties involved. White male wearing a black shirt and gray shorts and a black female was wearing a shirt and shorts.

I, Ofc. J. Lopez was traveling west on Truman Avenue. I was near the intersection of Truman Avenue and Windsor Lane when the call was aired over the radio. I began responding to the above-mentioned area and I informed Key West Communications of my response.

When I arrived on scene, I saw Ofc. S. Adorno, who was off duty at the time. Ofc. S. Adorno pointed at a male, and the male matched the description provided by Key West Communications. I walked over the male; I immediately identified myself as an officer and instructed the male to sit down. Once the male sat down, I noticed the male was bleeding from the back of his head, and had some blood around his right elbow. I informed Key West Communications; I was out with the male and provided them with the information of the injuries the male sustained. I requested Key West Fire Rescue to respond to the scene.

The male was later identified with his Texas driver's license as Hamza Yamani, (dob:08/27/1987). Hamza said he did not know he was bleeding and then said, "A lady hit me." I asked Hamza for the description of the female and he said, "Black." When asked further information of the female, Hamza was unable to provide me with a clothing description. When asked about the female's age, Hamza mentioned possibly in her 20s. Sgt. T. Miller, walked up and informed the female involved said she did not want further action. The female involved walked away. Sgt. T. Miller informed me the female said she was kicked and punched by Hamza.

Hamza appeared to be agitated and said it was not true. Hamza stated the female had followed him over.

I asked for Hamza's identification as I needed to document the incident. Hamza asked me if it was necessary and I confirmed by advising him that I needed it.

At this time, I did not know the identity of the involved female or if this was a physical domestic in nature.

Hamza stated he was attacked and he did not call the police. I asked Hamza where he was attacked, he pointed toward Duval Street area, followed by describing the female attacked him by slapping him on the face. Hamza stated the female asked him if he was an Israel national and then she proceeded by slapping him on the face to which he responded by pushing her away. Hamza stated after he pushed the female; he walked away. Hamza added he suddenly felt a punch. An unknown male walked up and said pointed at Hamza as he indicated Hamza was the male

who had "Beat up that woman." I asked the unknown male if he had seen the female and said the female had left. The unknown male stated again Hamza was the male, "Beating her up."

I asked Hamza again about the location where the situation had happened. Hamza said it happened on the sidewalk near the corner while he pointed near the intersection of Duval Street and Appelrrough Lane. I asked Hamza after the female had done that, Hamza interrupted me by saying two guys informed him, they had called the police. Hamza said he was told not to leave the scene and he remained on scene. Hamza stated he walked approximately 10 feet away and then at that moment I had arrived on scene. I asked Hamza several questions in an attempt to locate the female. I asked for her last known direction of travel, and he was unable to provide me with further information. Hamza said maybe she was wearing a skirt.

Key West Fire Rescue arrived on scene and they assessed the Hamza. I was by myself for approximately 9 minutes trying to get as much as I could to determine if the male and female were in domestic relationship. In addition, I did not have a victim at the time. However, based on the information I had gathered I determined the course of action was to document the incident and follow up with to investigate further. I determined I needed to attempt to get the female identified to move forward. At the time, I did not know who was the primary aggressor. Once an additional officer responded, I asked the officer to take photographs of Hamza's injuries. I then gathered paperwork from my vehicle.

Ofc. D. Christina responded shortly after and took lead on the incident since he was able to get further information. Ofc. D. Christina informed us to place handcuffs on Hamza. I searched Hamza by the front hood of my patrol vehicle. During the search, my front Axon Fleet Camera was activated, 3722. Please see Ofc. D. Christina's report for further information.

This incident was recorded with my body worn camera, 3722.

## **Supplemental Narrative By Samuel Adorno, 03/26/26 20:18**

On March 26, 2026, at approximately 0034 hours, I (Ofc. Adorno) was off duty in the area of Appelrrouth Ln and Duval St. While exiting the side entrance of Virgilio's (524 Duval St), I observed a white male, actively striking a black female with closed fist multiple times.

While immediately approaching the two individuals, the male landed another closed fist strike to the female's face, causing the female to fall to the ground.

Due to the males' violent actions and behavior, I delivered a single counter strike (right hand) to the individual, knocking him to the ground.

I continued to talk to the individual advising him the police were on the way and to not leave. The male became belligerent once again and began to walk West on Appelrrouth Ln, toward Whitehead St. Shortly after, Key West Police arrived on scene and detained the male.

I stayed on scene and provided a statement to Sgt. Stutz and Ofc. Christina.

## **Supplemental Narrative By Tiffini Miller, 03/29/26 20:24**

On Thursday, March 26, 2026, at approximately 12:30 a.m., I (Sergeant T. Miller) was off duty in the area of Appelrrouth Lane and Duval Street. I was exiting the side entrance to Virgilio's (524 Duval Street) with off duty Officer S. Adorno and off duty Lieutenant J. Dean, when I observed a black female and a white male in a physical altercation. I observed the male actively striking the female with a closed fist. At one point, the male punched the female so hard, she landed on the ground. I immediately went to the female and assisted her from the ground, asking what happened.

She advised the male had been hitting and kicking her. I contacted Key West Police Department Communications and advised Dispatch of the current situation. I tried to get the female to sit on the curb and wait for police, however, she

refused, stating she didn't want to meet with the police. I observed the female holding the side of her face, which was already swelling due to the strike(s) she sustained by the male's closed fist. I continued to speak to the female and asked that she wait for the police to arrive. She again reiterated she did not want to pursue charges and she did not want to meet with the police. At this point, she walked eastbound on Appelrouth Lane, towards Duval Street. The female did not provide me with her name or identifying information. Upon officers arrival, I met with Officers Christina and Lopez and provided them with the details of what I had witnessed. Sergeant Stutz responded to the scene and he was also provided with a statement. I had no further involvement in this incident.

### **Supplemental Narrative By Jeffrey Dean, 03/31/26 06:32**

On March 26, 2026, while off-duty, I (Lieutenant J. Dean) exited Virgilios along with off-duty Officer Samuel Adorno and off-duty Sergeant Tiffini Miller. As we were exiting Virgilios we saw a male actively trying to hit a female. The male appeared angry and belligerent. The male struck the female in the face with a closed fist which knocked her to the ground. The male continued towards the female as she was on the ground, and I felt without intervention the female would come to further harm. I positioned myself between the male and female as Officer Adorno delivered a single closed hand strike to the males face which knocked him to the ground.

After a short moment the male got up and continued to act belligerent repeatedly yelling that the female hit him. I confirmed with Sergeant Miller that on-duty officers were on the way and told the male to stay. The male refused and walked away. I began to follow the male, while keeping a safe distance, until officers arrived on scene and detained him.

I met with responding officers to give my statement and remained on scene until the investigation was concluded.

I had no further contact with the male, and did not have any contact with the female.

### **Video Follow-Up Narrative By Jack Gruba, 03/31/26 08:21**

On 3/31/2026, at approximately 1600 hours, I, Det. Gruba, met with the manager of Mary Ellen's, identified as John Gallo, to obtain video footage for case number 26-1475.

I assisted Gallo in finding the incident caught on camera. Gallo told me the footage takes a while to save, so he would email me the footage when it is ready.

At 1708 hours, I received the mp4 file from Gallo, via email. I uploaded the file into evidence.com and saved it on a flash drive, which was given to Sgt. Stutz.
