A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RANKING AND AWARDING THE RESPONSE TO RFP 25-002 TO THE LAW OFFICES OF DONALD E. YATES, P.A., FOR CODE COMPLIANCE SPECIAL MAGISTRATE SERVICES; DIRECTING THE CITY MANAGER TO NEGOTIATE AND EXECUTE CONTRACT IN Α SUBSTANTIAL CONFORMANCE WITH RFP 25-002; PROVIDING FOR AN EFFECTIVE DATE

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the sole response to RFP No. 25-002 for Code Compliance Special Magistrate was presented to the Commission, with a staff recommendation to award an agreement to the respondent, Donald E. Yates, P.A., and the City Commission accepted the recommendation and selected the proposal of Donald E. Yates, P.A.

<u>Section 2</u>: That the City Manager is authorized to negotiate and enter into a contract with Donald E. Yates, P.A., for Code Compliance Special Master Services, in substantial conformance with documents in the RFP Response.

<u>Section 3</u>: Funds for this Agreement are budgeted annually in account No. 001-2402-524-3100, and any necessary budget adjustments or transfers are hereby approved.
