Original Narrative By Ivan Golovanov, 11/23/25 01:04

On 11/22/2025 at approximately 2130 hours, I, Officer Golovanov, was dispatched to 301 Whitehead Street ("First Flight") in reference to a civil matter incident.

Upon arrival, I met a female (Andrea J. Canaves, DOB: 02/01/1994) who appeared intoxicated and informed me that they were unable to obtain a key for a rental golf cart. With Andrea was another female (Cristal L. Tejera DOB: 02/05/1991) who informed me that she was trying to reach a rental company for more than an hour to get another key for a golfcart, however when she was finally able to reach a rental company representative, she was informed that they cannot accomplished that, but they happy to provide them another golf cart tomorrow. Cristal was not satisfied with the rental company's way of solving the problem, so she started yelling at them, and they hung up on her.

Cristal and Andrea started demanding a police report for the incident, and I informed them that, unfortunately, this is a civil matter and I am not going to file a report. I also reminded Cristal and Andrea that the company had agreed to provide them with another golf cart the next day.

At this moment, Cristal and Andrea got belligerent towards me because I refused to do a police report and started getting in my face. I gave them both multiple verbal commands to walk away, but they both refused, and at one point, Andrea grabbed my left hand, so I had to push her away. To de-escalate the situation, I started walking away inside "First Flight"; however, Cristal and Andrea followed me and continued cursing at me. I gave again multiple verbal commands to both of them to walk away, and they both refused.

At one point, Andrea spat on my left shoe, so I handcuffed her. When I started walking Andrea away, Cristal grabbed Andrea and obstructed my attempts to walk Andrea to my patrol vehicle. I continued to give Cristal verbal commands to walk away, but she again refused. I instructed Cristal that if she did not walk away, she would be arrested. At this moment, Andrea turned her head towards me and spat on the left side of my face. I immediately performed a takedown and relocated Andrea to the ground in a controlled manner.

Cristal again stood in front of me and stated that she was not walking away. I instructed Cristal to place her hands behind her back, which she refused and started tensing her hands to fight my attempts to place her in handcuffs, to the point that my BWC detached from my chest and fell to the ground. At one point, Cristal was hugging a metal door to prevent me from handcuffing her. I eventually was able to handcuff Cristal. At this moment, Ofc. Osborne arrived at the scene, and both females were separated. Sargeant Miller, Sargeant Waite, and Ofc. Sharp arrived shortly after. I relocated myself to Duval St/Charles St. to pick up my patrol vehicle.

When I come back to the scene, Ofc. Sharp informed me that an employee (George M. McClean, DOB: 06/09/1971) of the establishment witnessed the incident and is willing to do a written statement.

At this moment, both females were sitting on the stairs of "First Flight". I instructed Andrea to stand up, but she refused. I again gave Andrea a lawful order to stand up, and she again refused, so I had to lift her by her left arm to walk her towards my patrol vehicle. Andrea immediately tried to drop her weight to the ground. I was able to escort her to a hood of my patrol vehicle, where she was searched with my Fleet camera activated. Andrea was repeatedly asked if she had anything illegal in her possession, and she responded that she did not. Andrea was placed in the back of my patrol vehicle. Cristal was also searched in front of the hood of my patrol vehicle and placed in the back.

I transported both females to MCDC without incident.

Inside MCDC, Sgt. Tijerino informed me that a baggie containing a white powder substance was found in Andrea's wallet. The substance tested positive for cocaine.

Based on the facts and evidence in this case, I believe that Andrea J. Canaves violated FSS 784.07-2b battery on a LEO. Andrea willfully and intentionally spat on my face while being handcuffed. During this incident, I was wearing a full KWPd class B uniform with my badge and holstered weapon. Andrea also violated FSS 843.02, resisting without violence. Andrea willfully and intentionally refused to obey my lawful order to stand up after she was placed under arrest, and then fought my attempts to walk her towards my patrol vehicle.

Based on the facts and evidence in this case, I believe that Andrea J. Canaves violated FSS 893.13.6a, possession of a controlled substance without a prescription. A baggie with powdered cocaine was found in Andrea's wallet by MCDC personnel.

Based on the facts and evidence in this case, I believe that Andrea J. Canaves violated FSS 951.22-1, introducing a

contraband article into a detention facility. Andrea intentionally introduced a narcotic into the county detention facility, and because the narcotic was found in her wallet, I believe that she was aware of its presence.

Based on the facts and evidence in this case, I believe that Cristal L. Tejera violated FSS 843.02, resisting without violence. Cristal willfully and intentionally refused to place her hands behind her back and fight my attempts to handcuff her. Cristal also continuously obstructed my attempts to escort Andrea from the scene after she was arrested.

My BWC, Fleet, and In-car cameras were activated during this incident and uploaded to Evidence.com.

I placed a written statement in the records department.

The baggie with cocaine was placed into the KWPD Property and Evidence.
