On Wednesday, April 20, 2022, at approximately 2307 hours, I (Ofc Andrade) responded to McDonald's, 3704 N Roosevelt Blvd, reference a trespass incident.

On arrival I met with a male employee. He told me that he had asked a female customer to leave that was parked outside the main entrance after finding her asleep behind the wheel, but she refused. He added that an MCSO Deputy was there making a purchase in the driver through. The employee asked the Deputy to ask her to leave also, but she refused his request as well.

I walked outside to the eastside of the property where I saw a female (later identified as Genna Christine Gambino) sitting in a truck bearing FL tag 25ARYC behind the driver's seat with the vehicle running. I also saw MCSO Deputy Sherriff Sergeant Hill.

I approached Gambino and asked her to tell me what was happening. Gambino said the following:

She had intentions on purchasing a milkshake. Gambino was parked outside texting on her phone when an employee knocked on her window startling her. She opened the door and confronted the employee. Gambino was told to "leave, or the cops would be called," by the employee, but she refused because she wanted to speak with the cops.

I asked Gambino for her identification. As she was providing it to me Ofc Howell arrived on scene. I handed over Gambino's identification to Ofc Howell. Ofc Howell researched Gambino via Key West Communication Channel 2. Ofc Howell informed me that Gambino had issues with her license and should not be driving, according to Channel 2. Ofc Howell instructed Gambino to get out of the vehicle, but she did not comply. Gambino became agitated and argumentative. I asked her to please turn off the vehicle and get out. Gambino began reaching for items in the vehicle. Ofc Howell told her stop and exit the vehicle. Gambino finally complied after grabbing a tan backpack. Ofc Howell researched Gambino's Florida driver's license and discovered that it was not valid according to F/NCIC.

We instructed Gambino to have a seat on a nearby curb on the property. Gambino reached for a cell phone and began to make a call. Ofc Howell instructed her to hang up the phone. After having to be told to do so several times she complied.

Ofc Malak and Ofc T. Anglin (with K-9 Jigsaw) arrived on scene. Ofc T. Anglin walked K-9 Jigsaw around the vehicle. Ofc T. Anglin informed me that K-9 Jigsaw had alerted on the vehicle. Ofc T. Anglin and I searched the vehicle. In the vehicle Ofc T. Anglin found a white tube with the Trulieve logo that contained a rolled cigarette of an unknown substance. I found drug paraphernalia consisting of a round metal "grinder" with the remnants of a green leafy substance.

Upon completion of the vehicle search I approached the area where Gambino was sitting. Gambino was on the phone again. Ofc Howell and I both told her to hang up the phone, but Gambino refused saying, "I don't fucking care handcuff me." Ofc Howell grabbed Gambino from the left arm, and I grabbed her from the right. As soon as I grabbed Gambino's right arm she tensed up and tried to pull away. We walked her to the hood of Ofc Malak's vehicle and placed her in handcuffs. Ofc Howell maintained his left hand on Gambino's right shoulder to keep her from moving. Gambino began to step away from the hood of the vehicle and Ofc Howell told her stop moving and put her stomach against the vehicle. Gambino then attempted to turn and face Ofc Howell. Ofc Howell prevented Gambino from doing so with his arm. Gambino replied with, "stop touching me," and attempted to do so again replying, "Nope." Ofc Howell again prevented Gambino from turning and forced her against the hood. Gambino's left leg swung backwards striking Ofc Howell in the left shin. Ofc Howell asked Gambino, "Do you really want to kick me right now?" Gambino answered, "I didn't kick you." Ofc Howell had to tell her to stop struggling as she was pushing backwards against him trying to keep her against the hood. Ofc Howell again had to force Gambino against the hood. Gambino's left leg purposely swung back again striking Ofc Howell in the left shin. We placed Gambino

in the back of Ofc Malak's patrol car.

Ofc Malak and I searched Gambino's tan bag subsequent to arrest. Inside the bag we discovered a white plastic container containing a green and brown leafy substance, and two sealed plastic bags decorated with a skull containing a green leafy substance. Also in the bag was a small green box, with six segmented compartments inside. The compartments contained four round orange-colored pills stamped "970," seven round orange-colored pills stamped "T376," and four orange and blue pills stamped "TEVA 7198." An internet check of the pills revealed the pill stamped 970 to be Buprenorphine Hydrochloride and Naloxone, a Schedule 3 controlled substance, the pill stamped T376 to be Amphetamine and Dextroamphetamine, a Schedule 2 controlled substance, and the pill stamped "TEVA 7198" not to be a controlled substance. Gambino was unable to produce a prescription for either of these substances. Gambino was also unable to produce a medical marijuana card.

I called the Poison Control Center, 1-800-222-1222, to verify my internet findings. I was informed by Sergio, case # M3688527, that the pill marked "970" was a Schedule 3 controlled substance, and the pill stamped T376 was a Schedule 2 controlled substance. I then spoke to Frank, case # M3688528, and I was informed the pill stamped TEVA 7198 was not a controlled substance.

Gambino had earlier said to Ofc Malak that she wanted to speak to a supervisor. Sgt Conaty arrived on scene and spoke with Gambino. Gambino complained that her rib was hurt and that wished medical attention. I requested Key West Rescue and they arrived moments later. Key West rescue quickly examined Gambino and informed her that there was not much they could do on scene and asked her if she wanted to be transported to Lower Keys Medical Center and she said yes. Gambino lifted her shirt to show the area she was complaining about, exposing her skin. There were no visible blemishes, marks, or discoloring's in the rib area. The exposed area was photographed and uploaded to Evidence.com via Axon capture.

Ofc Malak stayed on scene and waited for the arrival of Arnold's towing to tow the truck Gambino was driving.

I spoke with MCSO Deputy Sergeant Hill who informed who corroborated the account of the McDonald's employee. Sgt Hill added that Gambino drove the truck from where she was parked, in front of the main entrance, to the eastside of the property where I originally encountered them. Sgt Hill will be submitting a Key West Police Department Statement Form at a later date.

Gambino was transported to Lower Keys Medical Center by Key West Rescue accompanied by Ofc Howell. Ofc Howell stayed observing Gambino while at Lower Keys Medical Center. I arrived minutes later. Ofc Howell informed me that Gambino made a loud verbal threat to Ofc Howell while jumping out of the ER bed saying, "You don't know who you are fucking with. When you get off work, you are going to get fucked up." This threat was loud enough that a patient in the neighboring bay, Robert L. Wolff, heard her. I spoke with Wolff and he corroborated Ofc Howell's account. Also, a hospital staff member, Morgan Marie Stinson, heard the threat and filled out a Key West Police Statement Form. The form was submitted to the Key West Police Departments Records Section.

Gambino was cleared by Lower Keys Medical Center. Ofc Howell performed a search of Gambino's person before placing her into the back of my patrol car. Gambino admitted to placing a pipe in the ER bed. Ofc Howell retrieved a multicolored glass cylindrical smoking pipe with residue of a green and brown leafy substance pipe from the ER bed that Gambino had been in. Ofc Howell and I then transported her to the Monroe County Detention Center for processing.

I issued Gambino a traffic citation, AEU5S1E, for driving without a license. I signed and gave Gambino a copy of the citation and had her sign the agency copy. I informed her of her court date. The agency copy of the citation was

submitted to The Records Department at the Key West Police Department.

My BWC was activated during this incident and uploaded to Evidence.com.

Based on the facts and evidence, I believe there is probable cause that on 04/20/2022, Genna C. Gambino did knowingly and intentionally violate F.S.S. 784.07 Battery of Law Enforcement Officer, by actually and intentionally kicking Ofc. Howell in the shin twice, while he was engaged in his legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on 04/20/2022, Genna C. Gambino did knowingly and intentionally violate F.S.S. 843.02 Resisting without Violence, by actually and intentionally attempting to pull away from Ofc. Howell and me while we conducted a legal, lawful investigation, while we were engaged in our legal, lawful duties as uniformed law enforcement officers.

Based on the facts and evidence, I believe there is probable cause that on 04/20/2022, Genna C. Gambino did knowingly and intentionally violate F.S.S. 893.13-6A Drugs Possess Controlled Substance without Lawful Prescription, by actually and intentionally possessing four Buprenorphine Hydrochloride and Naloxone pills, a Schedule 3 controlled substance, and seven Amphetamine and Dextroamphetamine pills, a Schedule 2 controlled substance without a legal, lawful prescription.

Based on the facts and evidence, I believe there is probable cause that on 04/20/2022, Genna C. Gambino did knowingly and intentionally violate F.S.S. 843.01 Resisting with Violence, by purposely kicking Ofc. Howell in the shin as he detained Gambino, while he was engaged in his legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on 04/20/2022, Genna C. Gambino did knowingly and intentionally violate F.S.S. 322.34-10B1 Drive with Suspended Revoked License, by actually and intentionally operating a motor vehicle with a revoked Florida driver's license and without proper driver privileges.

Based on the facts and evidence, I believe there is probable cause that on 04/20/2022, Genna C. Gambino did knowingly and intentionally violate F.S.S. 893.13-6B Marijuana-Possess Not More Than 20 Grams, by actually and intentionally possessing two small clear plastic baggie with a green and brown leafy substance that field tested positive for marijuana as well as two partially charred hand rolled cigarette that contained a green and brown leafy substance that field tested positive for marijuana.

Based on the facts and evidence, I believe there is probable cause that on 04/20/2022, Genna C. Gambino did knowingly and intentionally violate F.S.S. 893.147-1 Possess and/or Use Drug Paraphernalia, by actually and intentionally possessing a metallic marijuana grinder with a green and brown leafy substance residue that field tested positive for marijuana, consistent with narcotics use, within his possession.

Based on the facts and evidence, I believe there is probable cause that on 04/20/2022, Genna C. Gambino did knowingly and intentionally violate F.S.S 918.13 Evidence Tamper or Fabricate Physical Evidence, by actually and intentionally attempting to conceal a multicolored glass cylindrical smoking pipe with residue of a green and brown leafy substance that field tested positive for marijuana with charred residue, commonly used to smoke marijuana, within the mattress of a hospital bed.

On Wednesday, 04/20/2022 at approximately 2302 hours; K-9 Ofc. Anglin, Ofc. Malak, Ofc. Andrade, Ofc. Andrade and I (Ofc. Howell) responded to 2704 North Roosevelt Boulevard (McDonald's Hamburgers) regarding call concerning an unknown white female subject possibly trespassing.

Key West Communication Channel One stated that a Monroe County Sheriff Deputy, Sgt. T. Hill (Witness), was already on scene with the unknown female subject. Ofc. Andrade was the first to arrive on scene. As I approached the scene, I witnessed an unknown white female subject sitting within the driver's seat of a blue Ford F-150 bearing a 25ARYC. The vehicle was still running. I identified the unknown white female subject, by a Florida driver's license, as Genna C. Gambino (DOB: 06/27/1988, Arrestee). Key West Communication Channel Two informed me that Gambino's Florida driver's license was revoked. I instructed Gambino to shut the vehicle off and to exit the vehicle. Gambino immediately became argumentative. Ofc. Andrade and I instructed Gambino to sit down on the curb near the vehicle, within the parking lot of McDonald's Hamburgers. I requested the assistance of K-9 Ofc. Anglin.

At this point, K-9 Ofc. Anglin and Ofc. Malak arrived on scene as our back up. As K-9 Ofc. Anglin arrived, Gambino became argumentative again and attempted to stand up several times. Gambino continuously attempted to rummage through her purse, as well as send texts and make phone calls on her cellular phone. Ofc. Andrade and I instructed Gambino to remove her hands from her purse and refrain from using her cellular device several times throughout the encounter. Gambino insisted she was just recording. I witnessed Gambino accept a phone call after I specifically instructed her to refrain from utilizing her cellular phone for officer safety and because we were conducting an investigation. Gambino shouted, "Fuck you, I know my rights" and continued to ignore my legal, lawful orders. Ofc. Andrade and I placed Gambino in handcuffs. Gambino began screaming obscenities at Ofc. Malak, Ofc. Andrade and me. Gambino became shouting at Ofc. Malak that she knew her rights and that she wanted to speak to a supervisor. Ofc. Malak requested a supervisor be enroute to the scene.

As Ofc. Andrade and I place Gambino in handcuffs, she immediately began to aggressively attempt to pull away several times. I instructed Gambino to "stop resisting" and "stop pulling away from me" several times. Ofc. Andrade and I walked Gambino to the hood of Ofc. Malak's patrol vehicle. Gambino attempted to pull away from me several more times and also attempted to turn around and place her face in mine. I pushed Gambino's shoulders forward with my forearm to prevent this action. As I pushed Gambino's shoulders forward, she purposely kicked my left shin with her left foot. I asked Gambino, "Are you really going to kick me right now?" She replied, "I'm not kicking you," while attempting to face me again. I again pushed Gambino's shoulders forward and Gambino kicked my left shin with her left foot for the second time. As this point, Ofc. Malak unlocked his patrol vehicle and Ofc. Andrade and I placed Gambino in the rear seat of Ofc. Malak patrol car. Ofc. Andrade and I were unable to complete our search subsequent to arrest of Gambino's person due to her aggressive actions.

Ofc. Malak and Ofc. Andrade searched Gambino's belongings subsequent to arrest. Ofc. Malak and Ofc. Andrade discovered a small white square container with a green and brown leafy substance that field tested positive for marijuana, within Gambino's backpack. Ofc. Malak and Ofc. Andrade discovered two multicolored plastic bags decorated with a skull containing a green and brown leafy substance that field tested positive for marijuana. Ofc. Malak and Ofc. Andrade discovered a metallic grinder with a green and brown leafy substance with charred residue that field tested positive for marijuana, consistent with narcotics use. Ofc. Malak and Ofc. Andrade discovered a white cylindrical tube, approximately three inches long, with a hand rolled cigarette that contained a green and brown leafy substance that field tested positive for marijuana. Ofc. Malak and Ofc. Andrade discovered a small green segmented pill separator. The small green segmented pill separator contained seven orange, round pills with T376 imprinted on one side that were identified through Drugs.com-Pill Identifier as a Schedule Two controlled substance Amphetamine and Dextroamphetamine 30 mg. Ofc. Malak and Ofc. Andrade also discovered four orange, round pills with 970 imprinted on one side that were identified through Drugs.com-Pill Identifier as a Schedule Three controlled substance Buprenorphine Hydrochloride and Naloxone Hydrochloride 8 mg/2 mg, within the small green segmented pill separator.

The small white square container with a green and brown leafy substance that field tested positive for marijuana, weighed 0.8 grams. The two multicolored plastic bags decorated with a skull containing a green and brown leafy substance that field tested positive for marijuana, weighed 10.8 grams. The white cylindrical tube, approximately three inches long, with a hand rolled cigarette that contained a green and brown leafy substance that field tested positive for marijuana, weighed 1.3 grams.

At this point, Sgt. Conaty and Sgt. Kouri arrived on scene. Gambino became screaming that I "slammed her on the hood of the patrol car." Initially, Gambino stated she had a preexisting injury of a bruised rib on her right side. Eventually, Gambino stated that she had a bruised rib because I slammed her on the hood of the patrol vehicle. Ofc. Andrade called for Key West Fire/Rescue. Gambino was transported to Lower Keys Medical Center by Key West Fire/Rescue on Rescue 3, reference Run Number: 22-2205 for a preexisting injury. I rode in the Rescue 3 due to Gambino's previous aggressive actions.

While at Lower Keys Medical Center, Gambino became aggressive, shouting obscenities and derogatory names at me, began standing up and attempting to close the door to the emergency room. I placed one of Gambino's handcuffs on the emergency room gurney to prevent her from attempting to get up again. Gambino became even more frustrated and began yelling derogatory, homophobic slurs toward me. Gambino stared at me, screaming "You don't know who you're fucking with," and "when you get off work, I will have people waiting to fuck you up." An off-duty Monroe County Deputy, Dep. R. Wolff (DOB: 07/03/1975, Witness) in the room adjacent to Gambino's overheard the entire threat. Dep. R. Wolff corroborated my account of the threats for Ofc. Andrade. Several nurses witnessed and overheard

Gambino's threat. Nurse Morgan M. Stinson (DOB: 03/01/1984, Witness) also corroborated my account of the threats and provide Ofc. Andrade with a signed witness statement. After gaining compliance of Gambino, I witnessed Gambino attempt to conceal a multicolored glass cylindrical smoking pipe with charred residue of a green and brown leafy substance that field tested positive for marijuana, commonly used to smoke marijuana, within the mattress of a hospital bed. Gambino was medically cleared at Lower Keys Medical Center by Dr. Jones. Ofc. Andrade and I handcuffed Gambino behind her back again and walked her to Ofc. Andrade's patrol vehicle. Ofc. Andrade and I searched Gambino subsequent to arrest. Gambino explained that she attempted to conceal the multicolored glass cylindrical smoking pipe with charred residue of a green and brown leafy substance that field tested positive for marijuana, commonly used to smoke marijuana, within the mattress of a hospital bed. I retrieve the multicolored glass cylindrical smoking pipe from the emergency room mattress and placed it in an evidence bag.

Ofc. Andrade and I transported Gambino to Monroe County Detention Center, without incident.

My BWC was activated for the initial encounter, arrest, and transport of Gambino to Lower Key Medical Center and Monroe County Detention Center. I uploaded the videos to Evidence.com.

On 20APR22 at 2316, I (Ofc. T. ANGLIN) responded to the parking lot of MacDonald's Hamburgers, located at 3704 N. Roosevelt Blvd, at the request of Ofc. N. HOWELL, who was out with a suspicious incident involving a 2004 blue Ford F150, FL Tag# 25ARYC, (See original report for details). After arriving on scene, Ofc. N. HOWELL requested that K-9 JIGSAW conduct a sniff of the exterior of the parked Ford, which was not properly parked in a parking spot, (See Axon video).

The operator of the parked Ford, GENNA GAMBINO was seated on the curb as I affixed my six-foot nylon lead to the one-inch nylon collar K-9 JIGSAW was wearing. I retrieved K-9 JIGSAW from the rear of my patrol vehicle and as I approached the front passenger's side bumper on the parked Ford, I observed a noticeable change in K-9 JIGSAW'S normal behavior. K-9 JIGSAW'S body became rigid and his respiratory effort increased as he abruptly pulled towards the driver's door. K-9 JIGSAW intensely scanned his nose upwards and propped his paws on the side of the parked Ford. K-9 JIGSAW stuck his nose into the open half door window, took in a deep breath, scanned towards the face of the driver's door itself, took in several deeper breaths and sat. I gave K-9 JIGSAW his reward and secured him in the rear of my patrol vehicle.

As I returned to the parked Ford, I could hear GAMBINO arguing with Officers on scene. Ofc. E. ANDRADE and I conducted a manual search of the interior of the parked Ford. I could smell the strong odor of vomit emanating from inside the parked Ford as I conducted my manual search of the interior. I located a medical Marijuana tube inside the driver's door pocket. I inspected the contents and observed a pre-packaged Medical Marijuana cigarette. Ofc. A. ANDRADE located a metal Marijuana grinder containing Marijuana residue inside on the front passenger's side of the parked Ford, (See Ofc. E. ANDRADE'S report for details).

After returning to my patrol vehicle, I could overhear a commotion and observed Officers handcuffing GAMBINO, (See reports for details). Ofc. N. HOWELL escorted GAMBINO towards the front of Ofc. T. MALAK'S patrol vehicle. Moments later, I heard Ofc. N. HOWELL say, "Stop kicking me" as GAMBINO was yelling something unintelligible at Ofc. N. HOWELL. I could not see below GAMBINO'S midsection due to my vantage point. Officers secured GAMBINO in the rear of Ofc. T. MALAK'S patrol vehicle.

Officers began searching GAMBINO'S backpack and located prescription pills and packaged Marijuana, (See reports for details). I inspected the case of GAMBINO'S cell phone and observed that it was loose. As I lifted the case, I observed trace amounts of a white powdery residue on the back of the phone. I conducted a field test on the powdery residue and the result was F.T.P. Cocaine. I also located more white powdery residue on the phone's screen itself. I conducted a field test on the residue and the result was F.T.P. Cocaine.

Officers requested a supervisor respond to the scene as well as an ambulance after GAMBINO began complaining of
