Article I - Summary Description of Project

To release this hold, the recipient is required to submit a request for approval of the purchase of the small unmanned aircraft system (SUAS) included in this investment to DHS/FEMA per the DHS/FEMA Authorized Equipment List (AEL), and the request must be approved by DHS/FEMA.
