A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING AN EXPENDITURE NOT TO EXCEED \$35,000.00 FROM STATE LAW ENFORCEMENT TRUST FUNDS TO THE FLORIDA KEYS COMMUNITY COLLEGE (FKCC) FOR POLICE ACADEMY TUITION FOR CADETS; AUTHORIZING THE USE OF THE POLICE REGULAR SALARIES AND WAGES (001-2101-12) FUND TO PROVIDE TEMPORARY SALARIES FOR THE PRE-SCREENED CADETS; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Key West Police Department finds that there is a shortage of certified police academy graduates available to fill employment openings in the Key West Police Dept.; and

WHEREAS, a significant reason for the shortage of academy graduates is the economic hardship of paying tuition at FKCC; and

WHEREAS, due to staff vacancies, the KWPD has adequate funds in the police general fund, to sponsor temporary salaries for up to seven pre-screened cadets while they attend the full-time police academy at FKCC; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an expenditure of State Law Enforcement Trust Funds in an amount not to exceed \$35,000.00 to FKCC for Police Academy tuition for pre-screened cadets is hereby authorized.

Section 2: That the use of funds from KWPD Regular Salaries and Wages, 001-2101-12, is hereby approved to provide temporary employee wages to cadets during the police academy.

Section 3: That any necessary budget transfers are approved.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
