#### **TUESDAY, AUGUST 20, 2013**

A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, August 20, 2013.

Mayor Craig Cates called the meeting to order at 6:02 p.m.

The City Attorney advised the City will be in Court for a continuation of a preliminary injunction hearing on the case involving Sunset Marina Residences of Key West Condominium Association, Inc.

Mr. Smith also congratulated Commissioners Clayton Lopez and Billy Wardlow for their reelection to serve three more years on the City Commission. The Commissioners ran un-opposed in their Districts.

# City Manager's Report

Request for Proposals (RFP) for Towing Services

The City Manager discussed with the Commission the City's direction to develop a RFP for Towing Services. The Commission gave their consensus to staff to move forward on drafting an RFP.

- FDOT Update

Several members from Florida Department of Transportation (FDOT) gave a report on changing the travel lanes of traffic on North Roosevelt Blvd from one-way to two-way traffic configuration and the impacts to the timeline for construction with the change up to the maintenance of traffic. FDOT'S District Six Secretary Mr. Gus Pego recommended a two-way traffic configuration with a middle lane for turning can be implemented by the middle of the month of October and the contractor would add crews to make this timeline work for a projected completion date of July 15, 2014 for construction on North Roosevelt Blvd.
