A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, DIRECTING CITY STAFF TO RECOMMEND WITHIN 60 DAYS REVISED REGULATION REGARDING RECREATIONAL VEHICLES AND RECREATIONAL VESSELS, INCLUDING ASSOCIATED TRAILER PARKING IN THE CITY OF KEY WEST; PROVIDING FOR A REASONABLE TIME TO CORRECT VIOLATIONS IN LIGHT OF PENDING PROPOSED REVISED REGULATIONS; PROVIDING CONDITIONS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Commission finds that current regulations regarding recreational vehicles and recreational vessels, including associated trailer parking, should be revised; and

WHEREAS, the streets of the SF district are typically wider and contain more off-street parking as compared with other districts in the City; and

WHEREAS, the City Commission desires to study the ability to modify its current parking regulations to permit the parking of recreational vehicles and recreational vessels, including associated trailer parking, on City Streets where there is no adverse effect on the public good; and

WHEREAS, the City Commission desires to study the ability to modify its current parking regulations to permit the parking of recreational vehicles and recreational vessels, including associated trailer parking, on private property where there is no adverse effect on the public good; and

WHEREAS, individuals violating the current regulations are given a reasonable time to come into compliance once a violation is detected and the alleged offender notified.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Manager and City Attorney are hereby directed to develop and recommend within 60 days revised regulations regarding parking for recreational vehicles and recreational vessels, including associated trailer parking, on public and private property within the City of Key West.

Section 2: That given the fact the Commission is considering revised regulations, a reasonable time to correct an alleged violation shall be no earlier than 90 days from the effective date of this resolution. Such 90 day period to correct the violation may only be granted upon the condition that the vessel or vehicle is properly registered and licensed; and (2) any such vessel is located on an operational trailer which is also properly registered and licensed; and (3) complies with the remaining provisions of chapter 70; and (4) does not

obstruct line of sight, impede traffic or create any other safety hazard.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
