A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING AMIGOS TORTILLA BAR TO CONDUCT A "CINCO DE MAYO" FUNDRAISER" FOR THE AMERICAN CANCER SOCIETY ON THE 400 BLOCK OF GREENE STREET FROM CORNER OF DUVAL STREET TO TELEGRAPH LANE SATURDAY, MAY 5, 2012, FROM 5:00 P.M. TO 12:00 MIDNIGHT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 400 BLOCK OF GREENE STREET BETWEEN DUVAL STREET AND TELEGRAPH LANE FROM 5:00 P.M. TO 12:00 MIDNIGHT; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 5:00 P.M. TO 12:00 MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA; PROVIDING FOR AN EFFECTIVE DATE

SECTION 1. That Amigos Tortilla Bar is hereby granted permission to conduct "Cinco De Mayo" on the days and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; and provided the organization meet the terms and conditions set forth by the City Manager, and 25% of gross revenue or \$1,000.00, whichever is greater shall be donated to the American Cancer Society.

SECTION 2. That Amigos Tortilla Bar is hereby granted permission for the closure of the 400 block of Greene Street between Duval and Telegraph Lane on the date and during the hours stated above.

SECTION 3. That Amigo Tortilla Bar is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, permission is granted to allow the sale and consumption of alcoholic beverages within the

enclosed area.

SECTION 5. That Amigo Tortilla Bar will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and they will placed side by side.

SECTION 6. That this resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
