- 1. **Concrete Path Damage:** Tree roots have caused significant lifting of the concrete pathway.
- 2. **Foundation Risk:** The roots are visibly encroaching on the home's foundation, posing a potential structural threat.
- 3. **Neighboring Property Impact:** The roots have extended into the neighboring property, creating challenges for maintenance efforts.
- 4. **Tree Structural Integrity:** The main trunk of the tree has a substantial crack. Furthermore, these trees are known for their brittleness and susceptibility to breakage.

As the property was recently purchased, the current homeowners do not possess documentation to confirm any pre-existing foundation damage. However, the photographs provide clear evidence of the concerning trajectory of the roots.

To address these issues, the tree owners intend to have a landscape plan developed, which will include recommendations for replacements, if necessary.


