A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING AN EXEMPTION TO COMPETITIVE BID REQUIREMENTS FOR THE PURCHASE AND INSTALLATION OF FIRE SUPPRESSION SYSTEMS FOR THREE CONCESSION STANDS FROM ATLANTIC COAST RESTAURANT AND MECHANICAL SERVICES, PURSUANT TO SECTION 2-797(4) OF THE CODE OF ORDINANCES, IN A TOTAL AMOUNT NOT TO EXCEED \$38,134.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, an invitation to bid (ITB #14-023) was properly advertised and scheduled to open on July 15, 2014, however no vendors attended the mandatory pre-bid meeting scheduled for July 9, 2014, and the bid was subsequently cancelled; and

WHEREAS, there is a need for fire-suppression systems, and City staff obtained price quotes from two vendors, with Atlantic Coast Restaurant & Mechanical Service submitting the lowest price quote; and

WHEREAS, Key West Code of Ordinances section 2-797(4)(b) provides "If in the opinion of the city manager exceptional circumstances exist to exempt a purchase from the competitive bid requirements of this subdivision for the best interests of

the city, he shall place a resolution before the city commission for approval of such exemption."; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an exemption to competitive bid requirements, and the expenditure of funds not to exceed \$38,134.00, to Atlantic Coast Restaurant & Mechanical Services is hereby approved, pursuant to section 2-797(4) of the Code of ordinances.

Section 2: That this purchase will be paid from the budgeted funds under account 101-7201-572-6300:

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
