**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING ZONTA FOUNDATION OF KEY WEST INC. TO CONDUCT AN ANNUAL RADIO ZONTA DAY ON FRIDAY, MAY 8, 2015, FROM 3:00 P.M. TO 9 :00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF A PORTION OF CATHERINE STREET BETWEEN SIMONTON STREET AND ENTRANCE TO GATO BUILDING PARKING LOT FROM 3:00 P.M. TO 9:00 P.M; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 3:00 P.M.TO 9:00 P.M; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOL BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Zonta Foundation of Key West, Inc. wishes to conduct a Zonta Day Fundraiser on Friday, May 8, 2015.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That Zonta Foundation of Key West, Inc. is hereby granted permission to conduct a fundraiser on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That Zonta Foundation of Key West, Inc. is hereby granted permission for a fundraiser on the date and during the hours stated above.

**SECTION 3.** That Zonta Foundation of Key West, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 4** That pursuant to Section 18-86 (b) of the Key West Code of Ordinances, the Zonta Foundation of Key West, Inc. is granted permission allowing the sale and

consumption of alcohol beverages within the enclosed area.

**SECTION 5.** the Zonta Foundation of Key West, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used an that they will be placed side by side.

**SECTION 6.** This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
