A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE BID OF EBSARY FOUNDATION COMPANY IN RESPONSE TO ITB #18-037 IN A TOTAL AMOUNT NOT TO EXCEED \$168,500.00, FOR TARPON PIER REPAIR - HURRICANE IRMA DAMAGE AT CITY MARINA AT GARRISON BIGHT; APPROVING NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in September 2017, Hurricane Irma caused extensive damage to several piers, including Tarpon Pier at City Marina at Garrison Bight; and

WHEREAS, one responsive bid was opened on August 22, 2018, in response to ITB #18-037, and City staff recommends award of bid to the responsive bidder; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of Ebsary Foundation Company is hereby awarded in an amount not to exceed \$168,500.00, as specified in the response to ITB #18-037, the terms and conditions of which are incorporated herein.

Section 2: That reimbursement funds are anticipated from FEMA for this unbudgeted expense, due to Hurricane Irma damage (Project No. HU1701G09-57563000), and any necessary budget transfers are authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney, that are consistent with ITB #18-037 and the approval granted herein.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
