Hi Marilyn,

My apologies for not getting back to you sooner, but yes, that is the correct layout. In the contract, it states that we are not allowed to stake anything into the ground. In order to safely secure the screen, we must stake four guylines along the screen, and are 1.5" in diameter. Is there any way we can change the contract to allow staking in that area? I will do my best to make sure it gets staked in the same spot every time, but I never saw an issues over at Bayview Park.

Also, it states that I must remove trash. Ourselves won't generate that much trash, it would most likely come from those who bring their own food/drinks as if they were going to the park anyways. Unless there is a dumpster nearby, I'm not sure we would be able to collect all the trash and take it somewhere. Is that something we can discuss as well?
