BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:


Section 1: That the contract between the City and MARC, Inc for trash removal is hereby extended for a period of two years.


Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.

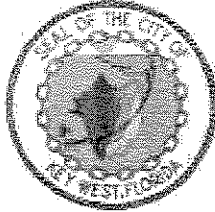

RE: Approval of a 2-Year Extension to the Key West Bight and City Marina's contract to MARC House for trash removal

ACTION STATEMENT:

This resolution will approve a 2-Year Extension as stipulated within the City's contract with MARC House which is due to expire in March, to provide trash collection services at Key West Bight and the City Marina at Garrison Bight with the same terms and conditions as the current contract.

BACKGROUND:

MARC House has been emptying the common area trash containers and picking up ground litter since 2002. They currently are doing a fine job. In 2007 the common area trash removal services were bid out to the public and MARC House was the lowest responsive bidder (Resolution 08-043). The contract with MARC House allows for a two year extension with the same terms and conditions which MARC House has agreed to.

PURPOSE AND JUSTIFICATION

Trash removal and litter pick up at the marinas requires several hours of work daily and if performed by city employees seven days a week it would require a three man crew. A three man crew of city employees with benefits would cost approximately \$115,000 a year. MARC House is currently charging \$41,580 to provide that service. This is a cost savings of approximately \$73,420.

OPTIONS / ADVANTAGES / DISADVANTAGES:

1. The City Commission can approve this 2-year contract extension with MARC House who are already knowledgeable of the tasks involved.
2. The City can go out for RFP for trash collection services at Key West Bight and the City Marina @ Garrison Bight. This option is not

recommended due to Staff's satisfaction with service provided and the terms of the existing contract. The City would issue a new RFQ in two years once this 2-year extension expires.

FINANCIAL IMPACT:

Monies are budgeted this year to continue with MARC House supplying this service. There may not be enough money budgeted if the contract is re-bid.

RECOMMENDATION:

Staff recommends that the City Commission select option 1, the approval of a 2-year contract extension with MARC House.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.



EXECUTIVE SUMMARY

SUBJECT: Trash Removal at Key West Bight and City Marina

REQUIREMENT STATEMENT: To provide for trash and litter removal at Key West Bight (CRA) and City Marina (City) 7- days a week in the most beneficial and cost effective manner.

BACKGROUND: An R.F.P. for common area trash removal at Key West Bight and City Marina @ Garrison Bight was publically advertised. Common area trash removal includes emptying all trash cans on the HarborWalk and Fuel Dock at Key West Bight twice daily and public trash cans throughout the City Marina Property once daily. The scope of work also includes picking up all loose litter and animal feces throughout both marinas daily.

Bids were opened on October 3rd 2007. There were two companies who submitted bids. MARC House bid \$3,500 a month and GME out of College Park Georgia bid \$ 2,166.67 per month. GME was considered non-responsive because they failed to fill out the mandatory forms included in the bid document or provide a bid bond.

This item was placed on the October Bight Board agenda however because of a lack of quorum the meeting was cancelled. On November 21st 2007 the Key West Bight Board unanimously recommended the award of this contract to MARC House for a term of three (3) years with the City having an option to renew at the same terms for an additional two (2) years. The contract will effectively begin October 1st 2007.

EFFICIENCIES GAINED & ALTERNATIVE COSTS: Trash removal and litter pick up at the marinas requires several hours of work daily and if performed by city employees seven days a week would have to consist of a three man crew. A three man crew of city employees with benefits would cost approximately \$115,000 per year. MARC House will be charging \$42,000 a year to service both marinas which would be a cost savings of approximately \$73,000 a year.

OPTIONS/ ADVANTAGES/ DISADVANTAGES:

1. The CRA/City Commission can award the trash removal contract to Marc House.

2. The CRA/City Commission can deny the award of trash removal contract to Marc House for budgetary reasons and instruct staff to re-bid the contract.

- While it is possible that a second R.F.P. may result in a lower bidder staff does not feel that a second R.F.P would be justified.

FINANCIAL IMPACT: The amount MARC House is charging for the trash removal is within the amount budgeted for this service in the current budget. The monthly fee for services provided will be split between Key West Bight (CRA) and Garrison Bight (City) with Key West Bight paying 2/3 of the bill or \$2,310 monthly and Garrison Bight paying 1/3 or \$1,155 of the monthly bill.

RECOMMENDATION: Staff recommends that the CRA/City Commission award the trash removal contract to MARC House with a commencement date of October 1st 2007.

WITNESSETH:

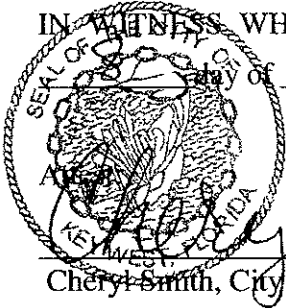

PART 3

CONDITIONS OF THE CONTRACT

GENERAL CONDITIONS
CITY OF KEY WEST

1. PREPARATION OF BIDS:

Bids will be prepared in accordance with the following:

- a. The enclosed Bid Response Form is to be used, other forms may be rejected.
- b. All information required by the Bid form shall be furnished. The bidder shall print or type his/her name and manually sign the Bid Response Form plus each continuation sheet on which an entry is made.
- c. Bid delivery time must be shown and shall include Sundays and holidays.
- d. Bidder shall thoroughly examine the specifications, drawings, schedule, instructions, and all other contract documents.
- e. All bids shall be submitted in original plus eight (8) copies.
- f. Bidders are advised that all CRA/CITY contracts are subject to all legal requirements provided for in City ordinances and/or State and Federal Statutes.

2. DESCRIPTION OF SUPPLIES:

- a. Any manufacturer's name, trade name, brand name, or catalog number used in the specifications is for the purpose of describing and establishing general quality levels. **SUCH REFERENCES ARE NOT INTENDED TO BE RESTRICTIVE.** Proposals will be considered for any brand, which meets the quality of the specifications for any item.

3. SUBMISSION OF BIDS:

- a. Bids and changes thereto shall be enclosed in sealed envelopes addressed to the City Clerk, City of Key West. The name and address of the bidder, the date and hour of the proposal opening and the proposal number shall be placed on the outside of the envelope.
- b. Bids must be submitted on the form furnished. Telecopy bids will not be considered.
- c. Unless otherwise indicated, all City of Key West Bids may be awarded on a line-item basis.
- d. Bid prices must remain in effect for ordering up to three (3) months from bid opening date.

4. REJECTION OF BIDS:

- a. The CRA/CITY may reject bids for any and/or all of the following reasons: (1) for budgetary reasons, (2) if the bidder misstates or conceals a material fact in his/her bid, (3) if the bid does not strictly conform to the law or is non-responsive to the bid requirements, (4) if the bid is conditional, or (5) if a change of circumstances occurs making the purpose of the bid unnecessary to the CRA/CITY. The CRA/CITY may also waive any minor informalities or irregularities in any bid.

5. WITHDRAWAL OF BIDS:

- a. Bids may not be withdrawn after the time set for the bid opening for a period of time as specified in the Instruction to Bidders.
- b. Bids may be withdrawn prior to the time set for bids opening. Such request must be in writing addressed to the City Clerk.

6. LATE BIDS OR MODIFICATION:

- a. Bids and modifications received after the time set for the bid opening will not be considered.
- b. Modifications in writing received prior to the time set for the bid opening will be accepted.

7. LOCAL, STATE, AND FEDERAL COMPLIANCE REQUIREMENTS:

- a. Bidders shall comply with all local, state and federal directives, orders and laws as applicable to this proposal and subsequent contract(s) including, but not limited to:
 - 1. Equal Employment Opportunity (EEO), in compliance with Executive Order 11246, as applicable to this contract.
 - 2. Minority Business Enterprises (MBE), as applicable to this contract.
 - 3. Occupational Safety and Health Act (OSHA), as applicable to this contract.

8. COLLUSION:

- a. The proposer by affixing his/her signature to this Invitation to Bid, agrees to the following: "Bidder certifies that his/her bid is made without previous understanding, agreement, or connection with any person, firm, or corporation making a bid for the same items and is in all respects fair, without outside control, collusion, fraud, or otherwise illegal action".

9. VARIANCE IN CONDITIONS:

- a. Any and all special conditions and specifications attached hereto which varies from General Conditions shall have precedence.

10. APPROPRIATIONS CLAUSE:

- a. If the contract or delivery extends beyond the current fiscal year, which ends on September 30, the contract shall be contingent upon the availability of funds appropriated for such purposes in the City's annual budget for the next succeeding fiscal year.

11. CLARIFICATION OR OBJECTION TO BID SPECIFICATIONS:

- a. If any person contemplating submitting a proposal for this contract is in doubt as to the true meaning of the specifications or other bid documents or any part thereof, he/she may submit to the Finance Director on or before five calendar (5) days prior to scheduled opening a request for clarification. All such requests for information shall be made in writing and the person submitting the request will be responsible for prompt delivery. Any interpretation of the bid, if made, will be made only by Addendum duly issued. Such addendum will be made available through the DEMANDSTAR web site. The City will not be responsible for any other explanation or interpretation of the proposed bid made or given prior to the award of the contract. Any objection to the specification and requirements as set forth in the proposal must be filed in writing with the Finance Director on or before five calendar (5) days prior to the scheduled opening.

12. DISCOUNTS:

- a. Bidders may offer a cash discount for prompt payment; however, such discount shall not be considered in determining the lowest net cost for bid evaluation proposed. Bidders are encouraged to reflect cash discounts in the unit price quoted.
- b. In connection with any discount offered, time will be computed from the date of receipt of supplies or services or from the date a correct invoice is received, whichever is the later date. Payment is deemed to be made on the date of mailing of the check.

13. AWARD OF CONTRACT:

- a. The contract will be awarded to the lowest responsive and responsible bidder whose bid, conforming to the Invitation to Bid, is most advantageous to the City, prices and other factors considered.
- b. The City reserves the right to accept and award item by item, and/or by group or in the aggregate, unless the bidder qualifies his/her bid by specified limitations as provided in 4 (4).
- c. If two (2) or more bids received are for the same total amount or unit price, quality and service being equal, the contract will be awarded according to City Ordinance Section 2-835(c).
- d. Prices quoted must be f.o.b. Key West, Florida, with all transportation charges prepaid unless otherwise specified in the Invitation to Bid.
- e. A written award of acceptance (Purchase Order) and a signed contract in a form acceptable to and approved by the City Attorney, mailed or otherwise furnished to the successful Bidder shall result in a binding contract without further action by either party.

14. LOCAL PREFERENCE:

- a. Pursuant to City Code 2-798 the City of Key West policy of local preference is applied to bids submitted by qualified local businesses. Local preference is 5% of quoted bidder, or \$1,000.00, whichever is less.

15. DAMAGE:

- a. Successful bidder(s) will be responsible for making any and all claims against carriers for missing or damaged items.

16. TRAVEL AND REIMBURSABLE OUT OF POCKET EXPENSE:

- a. Should there be travel and/or reimbursable out of pocket expenses relevant to this contract, Florida Statute 112.061 (Per Diem and travel expenses of public officers, employees, and authorized persons) will be followed.

17. INSURANCE REQUIREMENTS

- a. Workers Compensation: Insurance covering all employees meeting Statutory Limits in compliance with the applicable State and federal laws. The coverage must include Employers' Liability with a limit of \$100,000 each accident.
- b. Comprehensive General Liability: Coverage shall have minimum limits of \$1,000,000 per occurrence, combined single limit for bodily injury liability and property damage liability. This shall include premises and operations; independent contractors; products and completed operations, Broad Form Property Damage and XCU Coverage, and a contractual liability endorsement.
- c. Business Auto Liability: Coverage shall have minimum limits of \$1,000,000 per occurrence, combined single limit for bodily injury liability and property damage liability. This shall include owned vehicles, hired and non-owned vehicles, and employee non-ownership.

Special Requirements

- a. The City of Key West CITY is to be included as an additional insured on both Comprehensive General Liability and Business Auto Liability Policies.
- b. An appropriate Hold Harmless Clause shall be included.
- c. Current, valid insurance policies meeting requirements herein identified shall be maintained during the duration of the named project. Renewal certificated shall be sent to the City 30-days prior to any expiration date. There shall also be a 30-day notification to the City in the event of cancellation or notification of any stipulated insurance coverage.
- d. It shall be the responsibility of the contractor to insure that all subcontracts comply with the same insurance requirements that he is required to meet.
- e. Certificates of insurance meeting the required insurance provisions shall be forwarded to the office of risk management.

18. SURETY AND INSURER QUALIFICATIONS

- a. All bonds, insurance contracts, and certificates of insurance shall be either executed by or countersigned by a licensed resident agent of the surety or insurance company, having his/her place of business in the State of Florida, and in all ways complying with the insurance laws of the State of Florida. Further, the said surety or insurance company shall be duly licensed and qualified to do business in the State of Florida.

SCOPE OF WORK

ROUTINE GROUNDS MAINTENANCE AND TRASH REMOVAL

LOCATION

This request for proposal is to perform routine landscape services and daily common area trash removal at Key West Bight, 201 William St, Key West Florida and City Marina, 1801 N. Roosevelt Ave, Key West Florida.

Description: City Marina Properties are designated into five general areas for landscaping and garbage clean up.

1. Marina Dock Masters office and transient bathroom facility: its parking area, flower beds medians, sidewalks and boat ramp.
2. Charter Boat Row: sidewalks, flower beds, medians, parking lot and waste receptacles.
3. Liveaboard section : medians bordering Palm Ave , flower beds, and green spaces around tenant bath house and side walks from N Roosevelt Blvd running north up to the bridge underpass.
4. Key West Mooring Field Dinghy dock and shower trailer: parking lot, medians, flower beds and green spaces up to the north end of Palm Ave Causeway

Description: Key West Bight Properties are designated into eight general areas for landscaping and garbage clean up.

1. Caroline St Parking Lot, Islands in lot and shrub perimeter .
2. Green St Parking Lot, flower beds and shrub perimeter.
3. 901 Caroline St., weeds and stray grasses.
4. Coconut trees throughout property.
5. All green areas on Lazy Way and Greene St Plaza..

6. Metered lot off Margaret St.
7. Common areas adjacent to tenant structures.
8. Ferry Terminal grounds.

FREQUENCY

Each Property will be visited daily for trash removal and weekly for grounds maintenance. At the completion of the visit, a record will be made of work completed and signed by a representative of the Property with a copy given to the Representative. A landscaping plan and schedule will be determined that is acceptable to the City of Key West and the contractor.

I. TURF

A) Mowing, Trimming and Edging

- 1) Only equipment designed to produce a neat, manicured appearance will be used.
- 2) With each mowing, the direction of cut is to be changed to prevent complication and mower rutting.
- 3) Grass clippings are to be removed to prevent any unsightly turf appearance. Every effort must be made to keep clippings from being exhausted onto buildings or parked cars, into beds, tree wells, or mulched beds.
- 4) Trimming around obstacles and along grass edges will be accomplished at the same time using hand clippers or a nylon line trimmer.
- 5) All curbs and sidewalks (hard lines) will be mechanically edged once every mowing.
- 6) As required, grass that encroach the bed lines will be removed mechanically or chemically. When chemical edging is used, it is only acceptable under certain conditions and areas designated by the City.
- 7) After edging, all curbs, gutters, and walks will be blown free of turf clippings.
- 8) Every effort must be made to keep mowing equipment from damaging directional signs, ground lights, etc.

B) Fertilization & Related Chemical Applications

- 1) The turf fertilization program will be based upon general turf appearance and soil testing (run the first year and every other year thereafter during the contract period). The test results will determine nutrient deficiencies and specific chemical needs.
- 2) The City is to be provided a copy of these soil tests results.
- 3) The Contractor is responsible for all chemical applications identified in the test.
- 4) The expectation is that healthy green turf will be maintained.
- 5) The City will be notified in writing when fertilizer and weed control is applied. The notice will indicate the date and rate of the application.

C) Weed, Insect and Disease Control

- 1) Pre-emergent weed control will be accomplished as required to prevent weed seed germination. Post emergent weed control will be accomplished as required through out the year.
- 2) All turf will be monitored continually by the Contractor for the presence of insects and disease. Any control measure necessary will be performed on as needed basis. It is recommended that some type of preventative disease program be established.

D) Irrigation

- 1) The Contractor will be responsible for proper water management of all irrigated landscape areas and in accordance with any water usage restrictions imposed.
- 2) Routine irrigation will be scheduled during early morning hours so as not to interfere with pedestrian access.
- 3) When required, water restriction guidelines must be followed.
- 4) The Contractor will be responsible for damage to vegetation due to mismanagement of the irrigation system.
- 5) Any unsatisfactory irrigation conditions encountered, which will result in the loss of vegetation must be reported to the City in writing immediately.

II. TREES, SHRUBS, AND GROWDCOVERS

A) Fertilization and Related Chemical Applications

- 1) A complete analysis fertilizer will be applied to all ornamental plantings as dictated by soil test results.
- 2) Contractor is to apply any minor nutrients that are necessary.
- 3) The City must be provided a copy of soil test results.
- 4) Application rates and frequencies will be plant-specific and will be the responsibility of the Contractor to administer properly. The requirement is to maintain healthy plant material.

B) Weed, Insect and Disease Control

- 1) All areas on both properties are to remain weed free.
- 2) Chemical weed control applications (pre and post-emergent) should be utilized in all plant bed areas and in cracks, joints and edges of sidewalks, around buildings and paved areas.
- 3) Weeds in high visibility areas must be manually removed after chemical applications.
- 4) All ornamental plantings are to be monitored for the presence of insect and disease problems. Any control measure necessary will be performed on an as needed basis.
- 5) Weeds in sidewalks, curbs, beds, etc. shall be treated weekly as needed with "Round-up," "Vantage," etc. Herbicides of high toxicity will not be acceptable.

C) Irrigation

- 1) The Contractor will be responsible for proper water management of all irrigated ornamental plantings and in accordance with any water usage restrictions imposed.
- 2) Hand watering is utilized as needed.
- 3) The Contractor will be responsible for damage to any ornamental planting due to mismanagement of the irrigation system.
- 4) Any unsatisfactory condition encountered, which will result in the loss of ornamental plant material, must be reported to the City in writing immediately.

D) Pruning

- 1) All trees, shrubs and groundcovers should be pruned as needed to develop the natural form of the plant, to eliminate diseased or damaged growth, to selectively thin a plant to allow good air circulation, to remove unsightly sucker growth and to eliminate possible areas of concealment.
- 2) Deep pruning and structure pruning are to be done as needed.
- 3) Flowering ornamentals are to be pruned according to time-specific requirements to encourage flowering.
- 4) To maintain shape and form, and to conform to security considerations, periodic pruning is done as required throughout the contract.
- 5) Groundcovers are pruned to insure containment within certain areas.
- 6) Trees are to be limbed to 8 to 10 ft on pedestrian walks and in parking lots for clearance. No more than 25% of the tree's living crown is to be removed in one year, unless encroaching on utilities. Tree topping, shearing, or branch tipping are not allowed. The Contractor will not be responsible for pruning trees beyond 15 ft or responsible for removal of trees with a diameter greater than 6 inches. Trees outside of these specifications will be done by contractor on a billable basis.
- 7) All coconut trees on the properties will be hurricane trimmed annually before the start of hurricane season.
- 8) Throughout the contract coconut trees will be maintained so there are no hanging fronds or mature coconuts on the trees.
- 9) Where practical, it is preferred that pruning is done by hand with clippers, saws, pruners, or loppers and not grass shears.

E) Mulching and Trenching

- 1) Ornamental beds and tree wells are to be mulched at a frequency determined by the City, generally in January/February and July/August. Additionally, any areas disturbed by maintenance practices (weeding, edging, planting, leaf removal, blowing) will be re-mulched as required to maintain a neat appearance. Only mulch will be billed to the City as billable.
- 2) The type of mulch used will be site-specific and compatible with the existing landscape.

- 3) All mulch should be free of trash, debris and decomposed material. It must have the proper color.
- 4) Mulch is to be applied to a depth which creates an attractive appearance but not to exceed 3 inches.
- 5) All ornamental bed lines and tree wells are to be properly trenched prior to mulching. A 3 inch trench should be maintained along all turf bed edges and seasonal color bed lines. Where appropriate, the mulch is to be tucked and rolled in to the trench.

F) Plant Removal

- 1) The Contractor should notify the City of any dead plants. Once the City grants permission, the Contractor is to remove and dispose of them off-site.
- 2) Plant replacement is not part of this contract unless the Contractor is responsible for the loss due to negligence.

F) Staking

- 1) All ornamental vines growing up trellises should be re-secured as needed.

G) Hard Edging

- 1) The hard edging along the ornamental bed lines should be kept anchored below the mulch. If it is disturbed by pedestrian traffic or equipment, it is to be repositioned as needed.

IV. IRRIGATION MANAGEMENT

A) Operation

- 1) The Contractor will be responsible for monitoring the irrigation system for proper water management and in accordance with any water restrictions that may be imposed from time to time.
- 2) The automatic system is to be checked bi-weekly to insure proper operation by the controller. As part of this, each control clock should be checked for date and time accuracy.
- 3) Included in these routine system checks will be sprinkler head adjustment, nozzle/screen cleaning and the identification of valve malfunction, water meter leakage and PVC irrigation line breakage.
- 4) The Contractor is responsible for repair to the system if damage occurs due to Contractor's negligence.
- 5) Maintenance involving more than routine service checks and inspections is not part of this contract.
- 6) The Contractor will notify the City in writing of any damage or failure in the system. At this time the Contractor may submit an itemized repair cost.
- 7) It will be the decision of the City, as to who will make the repair.

V. TRASH REMOVAL (MAY BE BID WITH LANDSCAPE SERVICE OR SEPARATELY)

Trash/Debris Removal and Common Area Cleaning

- 1) Trash and debris located on the properties and around all parking areas will be collected and deposited in compactor daily.
- 2) Trash may never be placed or blown on property surrounding the site.
- 3) Trash receptacles will be emptied twice a day at Key West Bight and once a day at City Marina.
- 4) Special attention will be made to ensure that all litter, bottles, cans, cigarette butts, animal feces, etc are removed from parking areas, plazas, and walkways daily.
- 5) It is not the responsibility of the contractor to remove trash from the docks at either marina with the exception of the trash cans on the fuel dock at Key West Bight that are for public use.
- 6) Empty all wastebaskets located on the properties and Harbor Walk.
- 7) Waste receptacles will be cleaned and washed regularly. Scraps of litter that fall between the outside of receptacle and inside hard liner will be removed regularly.
- 8) The City will provide trash can liners.
- 9) The City will provide a list of all trash receptacle locations on both properties.
- 10) During special events such as Fantasy Fest, New Years, Race Week, etc contractor will monitor waste receptacles and empty more often as needed. The City will designate special events.
- 11) Contact phone numbers for Contractor's supervisors will be provided to City.

VI. MISCELLANEOUS

- 1) The Contractor will be responsible for the instruction and supervision of all personnel to insure that safety measures are practiced while working on the site.
- 2) Only state licensed individuals or persons supervised by licensed individuals will be able to apply pesticides.
- 3) The Contractor will be required to show proof of a state approved pesticide contractor's license and liability insurance.
- 4) All areas treated with pesticides will be posted if required by the state.
- 5) Complete records (application data, chemical labels, and Material Safety Data Sheets) should be available upon request.
- 6) All utility lines must be marked by the utility locator service before any trenching or digging at a depth greater than 6 inches is done.
- 7) Supervisors shall provide their cell phone numbers for contact purposes.

VII. QUALITY CONTROL

- 1) Representatives of the Contractor will monitor the landscape regularly to ensure

that the highest maintenance standards are being met. Inspect all locations quarterly with results reported in writing to the City. To ensure ongoing quality, Contractor will provide recommendations for design and material selection for new landscape areas or re-planting of existing areas, as requested by the City but no less than annually.

- 2) At the City's discretion, inspections of the property will be scheduled with the Contractor to critique the work.
- 3) After each inspection, a representative of the Contractor will prepare a written summary noting any items needing attention. A copy will be given to the City within 5 work days.
- 4) The City will expect the Contractor to address all items within 2 weeks. If the Contractor feels that this impractical, the City is to be provided with a written, detailed action plan showing completion dates and describing corrective measures that will be taken for each item not completed.
- 5) The Contractor will be penalized for failure to make weekly service visits, as stipulated by the terms of the contract.
- 6) The Contractor will guarantee all existing plant material after the initial six months of the contract. This includes pre-existing conditions but does not include problems resulting from fire, vandalism, etc.
