A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE FOR THE FIRE DEPARTMENT OF ONE (1) NEW HORTON AMBULANCE FROM REV RTC, PURSUANT TO GOVERNMENT CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES IN A TOTAL AMOUNT NOT TO EXCEED \$204,987.00 (INCLUSIVE OF PREPAYMENT/LOYALTY DISCOUNTS); AUTHORIZING NECESSARY BUDGET TRANSFERS TO USE GRANT FUNDING AND CITY FUNDING TO COMPLETE THE PURCHASE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City administrative staff has recommended the purchase of one new Horton ambulance from REV RTC, under the Florida Sheriff's Association, and the Florida Association of Counties Bid No. FSA16-VEF13.0, Specification #01 for fire/rescue vehicles and other fleet equipment, pursuant to section 2-797(3) of the Code of Ordinances; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one (1) new Horton Ambulance in a total amount not to exceed \$204,987.00, from REV RTC, pursuant to government contract, pursuant to section 2-797(3) of the code of ordinances, is hereby approved.

Section 2: That partial funding for this purchase is anticipated to be received through State of Florida grant funding in the amount of \$142,283.00, and a transfer of funds from account

101-2201-522-6400 in the amount of \$62,704.00 is authorized to complete the purchase.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
