## -- Amber Blazek Arrest Narrative:

On 5/29/2023 at 1619 hours, myself, Officer Abreu and Officer Santiago responded to 119 Golf Club Drive, in reference to a welfare check. Upon arrival, Officer Abreu and Officer Santiago spoke with the reporting party, a neighbor, who stated she was concerned about her neighbor, Amber Blazek, who seemed to be having some sort of mental health crisis. The neighbor advised that Amber came up to her child and started saying things like "your dad is not your real dad" and was yelling at him for no reason. The neighbor advised Amber is erratic and she was concerned for Amber's son, who is inside of the residence with her. (Please see CAD# 231490127)

Contact was attempted with Amber by Officer Abreu at her home and Amber refused to speak with her. We tried to telephone Amber and knocked on the door several times, all with negative results. Concerned now, for a 4 year old boy inside of the residence, Amber's son, Bodhi, I reached out to Bodhi's father, Jakub Blazek, who painted a picture about Amber's mental health.

Jakob advised that Amber is diagnosed with bi-polar disorder and he feels as if she is having some sort of mental breakdown. Jakob advised Amber is delusional and thinks that both he and Amber's mother, Michelle, are trying to hold her child hostage and take him to a sex trafficking ring where Michelle is the leader. Jakob advised Bodhi usually stays primarily with him and explained that Bodhi will typically ask to spend the night at his moms, then go back to Jakub's house, etc. Jakub explained on a recent visit, Bodhi ran up to Amber at her home because he was happy to see her and Amber took him inside and would not give him back to his father. Jakub also made statements that Amber told him she believes he fathers all children and has fathered over 100 children on the island of Key West.

While on scene, Amber's mother, Michelle Davenport showed up and also painted a picture of Amber's mental heath condition. Michelle also advised that Amber has Bi-Polar Disorder and is having a mental breakdown, which is being exacerbated by Amber and Jakub's divorce. Michelle advised Amber is delusional and she is concerned for the well being of her grandchild and thinks that Amber is in an altered sense of reality. Michelle explained that Amber called her Psychiatrist yesterday, earlier in the day and the Psychiatrist told her to increase her dose of medication.

This now totals three different people who have notified Police that they feel Amber is delusional and erratic and that they are concerned for the well being of her son.

Sergeant Duponty made contact with Amber through a small window next to the front door, abeit very briefly. Amber, again, refused to come outside and talk to him. Amber closed the blinds and refused to come to the door. Sergeant Duponty made the determination that there was nothing further we could do to assist and advised us all to leave the scene.

Approximately 7-10 minutes later, 911 dispatchers received a call from Amber's mother Michelle, who advised she went into Amber's townhouse, still concerned for her grandson (Michelle is a leaseholder) and Amber grabbed her by the hair, kicked her out of the house and kicked her, which caused Michelle to fall backwards down the stairs. Michelle claimed she was uninjured and refused rescue when asked.

Since Amber was now being physically violent with others, Sergeant Duponty questioned Amber's mental health state and determined we needed to complete a welfare check, and determined exigent circumstances existed to enter her residence. Arrangements were made and a key to Amber (and Michelle's) townhome was provided to Police. All

Police Officers on scene were uncomfortable leaving the scene and leaving Bodhi in Amber's care until a proper evaluation and welfare check could be conducted.

BATTERY

When Police tried to enter, Amber immediately came to the door, threatening to spray Police with a bottle of pink Pepper Spray, which she displayed, if they tried to enter her house. Officer Abreu and Sergeant Duponty attempted to communicate again with Amber through the front window and reason with Amber and Amber repetitively threatened to spray officers if they entered. Both Sergeant Duponty and Officer Abreu were very clear and compassionate with Amber, trying very hard to reason with her. Sergeant Duponty tried to enter the residence and Amber eventually decided to send her son Bodhi outside through the front door, when this happened, Amber had Bodhi sitting on the ground with her, with pepper spray in hand and was holding him in a "bear hug" type of fashion. I grabbed Bodhi and immediately escorted him away from his mother to safety. While waiting on Bodhi's father to retrieve him, I both heard and observed a fight occurring inside of Amber's residence between Amber and Officers. Jakub took Bodhi from the scene and I entered the residence where Sergeant Duponty and Officer S. Perez had Amber on the ground. As I entered the residence, I immediately began coughing, having trouble breathing and my arms and face felt like they were on fire. Sergeant Duponty, Officer S. Perez and Officer Abreu advised they had all been pepper sprayed by Amber. Officers inside gained control of Amber, who was cuffed in the front of her body at this time, and Amber was brought outside to Officer Abreu's patrol car. After being searched, Amber resisted and pulled away from me and I corrected her action, turning her around to face the patrol car. Amber immediately pulled away from me again and sat in the back of the patrol car and proceeded to intentionally and forcefully kick me in the arms, shoulder, legs and the left side of my neck and face using both of her legs. I grabbed my Taser and explained to Amber that if she made one more move, she would be Tased. Amber advised immediately that she would stop and started to calm down. Amber was hobbled and held at Taser point until additional units arrived on scene to assist.

Rescue responded to the scene to evaluate and assist all Officer's on scene. There were no serious injuries reported; however, all Officers on scene were feeling the effects of the Pepper Spray (trouble breathing, coughing, extreme burning sensation on face, etc.) which Amber had sprayed them with.

It is my belief that Amber violated the following Florida State Statutes:

Aggravated Battery on a Law Enforcement Officer x 3, FSS 784.07 (2D), by using a weapon and intentionally pepper spraying 3 uniformed Police officers with visible badge and KWPD identifiers, who were actively on duty, causing Officer incapacitation

Battery on a Law Enforcement Officer, FSS 784.07, by intentionally kicking a uniformed Police Officer with visible badge and KWPD identifiers in the arms, neck and face, who was actively on duty, against their will, while trying to affect an arrest.

Child Neglect/Endangerment, FSS 827.03 (1b2) by refusing to provide Police Officers access to a minor child, to determine his welfare and allowing the child to witness a volitile and violent encounter with the Police, and family members. Refusing to allow Police to check the welfare of a child is an intentional and dangerous act that could reasonably be expected to result in mental or physical injury to the child and could have easily been avoided.

Resisting with violence, FSS 843.01, by intentionally pulling away from and kicking a uniformed Officer, who was on duty, wearing a visible badge and KWPD identifiers, who was attempting to affect an arrest, in addition to, intentionally pepper spraying 3 uniformed Police Officers who were on duty.

Resisting without violence, FSS 843.02, by refusing to cooperate with Police and refusing Police access to check the welfare of a minor child, who may have been in danger.

Battery, FSS 784.03, by intentionally grabbing the victim against her will by the hair, and kicking the victim, causing the victim to fall backwards down the stairs.

Amber was arrested and transported to the Monroe County Jail. My Axon bodycam and my Axon patrol car cam were active during this incident and uploaded to evidence.com. An online report was made to the DCF abuse hotline. I spoke with CPI Investigator Jean Curtis, who advised that due to the nature of the call, and the level of aggression Amber displayed, she would most likely shelter Bodhi and place him with his father, Jakub, until Amber's mental health and aggression improves. On Monday, May 29, 2023, at approximately 0459 hours, I, Officer Santiago Perez was dispatched as a backup officer to 119 Golf Club Drive. Reference a resident stating her neighbor was throwing rocks at her house and saying she was going to take away their kids. On my arrival Officer I. Golovanov was on scene and informed me the night shift had responded to the same address earlier in the night.

I made contact with wit the resident at 119 Golf Club Drive, later identified as Amber Blazek. after knocking and the front door and ringing the doorbell. Blazek came to the front door without opening the door. I was able to see Blazek through the glass part of the door and she was holding a cellular phone in her hand. Blazek told me she did not want to talk to me and asked me to leave. Blazek also told me she was on the phone with FWC.

I was informed by Key West Police Communications division (Comm 1) that Blazek was on the phone with FWC and saying to their dispatched that her mother and husband were trying to take her son hostage. Blazek was also telling FWC dispatch that the police was next door taunting her. I contacted Comm1 and asked if they knew if Blazek son was in the house with her, Comm1 told me he was not. At this point since Blazek did not want to speak to me, I left the scene.

At approximately 1307 hours, on the same day, Officer Abreu, Officer Yenny Young and I, were dispatched to the same address (119 Golf Club Drive) reference a neighbor complaining about Blazek acting erratic the few past days, harassing people. Blazek neighbor told us Blazek ran across the parking lot earlier and screamed at her son "your daddy is not your daddy". We tried getting Blazek to speak to us and evaluate her mental status, Blazek again refused to speak to us. While on scene, Blazek ex-husband came to the house and said Blazek was acting erratic and delusional and said he was worried for the wellbeing of his son. Blazek mother also showed up and expressed the same and told us she was concern about Blazek being capable of harming her own son based on her mental status. At this point Blazek cover the top half part of glass door with a blanket, preventing us from seeing inside the house. We called Sgt. Duponty to the scene. We all worked on getting Blazek to come out and speak to us, Blazek refused. We cleared the scene.

As I was driving back to the police station, I was notified over the radio by Comm1 about Blazek's mother been battered by Blazek, Officers, Young, Abreu, Sgt. Duponty, and I, made our way back to the scene. Based on the totality of the circumstances, we concluded that Blazek's four-year-old son could be in danger in her possession and could possibly be mercy murder by Blazek due to her delusional state of mind. We Planned to obtain a key from Blazek's mother who is the legal tenant of the unit to gain entry and remove the four-year-old out of the house. We went back to the front door to try to have Blazek comply for the safety of the child. Blazek made threats to use pepper spray on us if we were to enter the house. After struggling to open the door for a few minutes, Blazek released her son to Sgt.

On May 29th, 2023, at approximately 1307 hours, Ofc. S. Perez, Ofc. Jennifer Young and I (Ofc. Abreu), were dispatched to 119 Golf Club Drive, Key West, FL, in reference to a welfare check.

I was familiar with the address we were responding to as officers had responded 4 times prior within the last 24 hours. I was also familiar with the female we were conducting the welfare check on (Amber Blazek). Ofc. Perez responded to this address in the earlier hours of the shift around 0530 hours, to conduct a welfare check also as Amber was on the phone with Florida Fish and Wildlife (FWC) dispatch telling them she was not safe, and she felt as if her son was going to be taken hostage. When Ofc. Perez arrived at that call in the morning Amber refused to open the door to speak with Ofc. Perez, instead she told him through the door she was fine and didn't want to speak with him. At this time, Ofc. Perez did not believe Amber presented as a threat to herself or others and there were no signs of Ambers son, (Bohdi Blazek), being present.

Upon my arrival, I met with the reporting party, Adrianna Carroll. Carroll stated that she was very concerned for Amber's son Bohdi, as Amber is having some sort of mental episode. Carroll stated she was at the pool with her family when she saw Amber outside on her front porch. Carroll stated Amber came running out of her porch area and towards Carroll's son screaming "Your dad is not your real dad". Carroll stated she told Amber to get away from her son and made her son go inside the house as Amber was clearly not in her right state of mind. Carroll stated her son is friends with Amber's son and she was very concerned for his safety. Ofc. J Young and I approached Amber's home, and I rang the doorbell. Ambers front door was a door that had a glass window in it. I could see in the house which appeared very messy with clothing scattered around the floor and staircase. Amber came down the stairs with her son and stood in front of her door on the inside. Amber refused to open the door to speak with me as she stated she "didn't feel safe and did not want to talk to me". Note it was a little difficult for me to see clearly inside the home as the lights were not on inside the house and it was very sunny outside so there was a glare on the glass preventing me from a clear view inside the home. Amber's son appeared to be well and smiled at me through the glass. Amber's son also mentioned to me that he had a cat which I saw the cat through the window. Amber picked her son up and carried him upstairs after telling me she was done talking to me. I knocked again and asked Amber to come speak to me, but she ignored my request. At this point, I knew the child was okay but due to the several calls with in the last 24 hours and now a neighbor calling stating she is chasing a child screaming that their father isn't the father was very concerning.

Ofc. Young, contacted Jakub Blazek (Amber's husband and father of Bohdi). Ofc. Young wanted to gather further information to make sure that Bodhi was safe with Amber as her behavior had been erratic and since she was refusing to speak with us to make sure they were both safe. Please see Ofc. Youngs body camera footage which recorded the conversation with Jakub. To summarize the conversation, Jakub said he does believe that Amber is a good mother and in her right mind she wouldn't hurt her son but lately (with in the last month) Ambers mental health has taken a huge

turn. Jakub stated that Amber is diagnosed Bipolar and seems to be extremely manic recently. Jakub stated he does not feel comfortable with Bohdi being with Amber as her behavior is so irrational. Jakub stated Amber is convinced that he is running a child sex trafficking ring and that her mother (Michelle Davenport) is the "ringleader" of this. Jakub stated Amber is convinced he is the father of over one hundred children, and he is going to take her son hostage. Based on these statements by Jakub, coupled with the multiple calls now within the last 24 hours at Ambers home, I did not feel comfortable leaving without checking the welfare of Bohdi and evaluating Ambers mental state. Ofc. Young called Sgt. Duponty to advise him of what we had and to see what our options were as Amber was refusing to come talk to us and refusing to allow us to see or talk to Bohdi. We were unable to evaluate the status of her mental health at this point.

Sgt. Duponty responded to the scene. While he was enroute to our location, Jakub and Ambers mother (Michelle) arrived on scene. Michelle introduced herself to us as Amber's mother and expressed extreme concern for her grandson. Michelle stated she is in fear for Bohdis life due to Ambers mental state and recent behavior. Michelle stated the home was hers and she was allowing Amber to stay there as she was in the process of a divorce and had nowhere to go. Michelle stated she had the key for the home but after yesterdays incident (KWPD CAD # 231480199, #231480222, #231490045, #231490050, #231490116, #231490127, #231490132), she left her keys inside the house. The listed KWPD CAD numbers are all the times KWPD has had contact with Amber in the last 24 hours. Sgt. Duponty determined that at this point we did not have enough to make contact with Amber. Sgt. Duponty told us all to leave the scene and meet at the station so we could review all the previous calls from the last 24 hours and discuss our possible options on how we could get Amber to willingly talk to us. We all cleared the scene.

While enroute to the station, Key West Dispatch advised us that Michelle had just called 911 screaming that Amber had just assaulted her and kicked her down the stairs. We all responded back to 119 Golf Club Drive. Michelle advised she tried to climb through her kitchen window. Michelle stated Amber grabbed her by her hair and pulled her inside the home. Once Michelle was inside Amber opened the front door and kicked her down the front stairs with consisted of about 4 or 5 steps. Michelle stated this took place in front of Bohdi. We noticed Amber had placed a towel in front of the glass of the front door which completely cut off our ability to see inside the home. Amber was in the house holding the towel screaming at us to leave the house and refusing to come talk to us. Michelle told us Amber was placing heavy furniture in front of the door in attempt to barricade herself in the house. Key West dispatch advised that Michelle had contacted a lock smith to come open the door for her. Michelle had canceled the locksmith and contacted her friend that had a copy of her house key. Ofc. Young drove to Bay Point to retrieve the key for the home. When Ofc. Young left the scene to go retrieve the key, we told Amber we were leaving in attempt to calm her down for some time while we waited for the key. When Ofc. Young arrived back at the home with the house key, Sgt. Duponty explained to us that we were going to open the door and try to talk to Amber. Sgt. Duponty instructed me and Ofc. Young to enter the home first to grab Amber and sit her on the couch and to give Bohdi to Michelle and Jakub while we spoke with

Amber. We approached the home quietly with the key. As soon as I put the key into the bottom lock, Amber put her face in front of the glass while holding a pink canister of pepper spray in her hand in front of the glass. We instructed Amber several times to come speak with us and that she was not in trouble. Bohdi was standing right in front of Amber while we attempted to talk to her through the glass. Michelle and Jakub were at the back sliding glass door hoping Bohdi would listen to our instructions to run to them. Our main objective was to separate Bohdi from Amber as she had a canister of pepper spray in her hand and was not thinking of Bohdis safety at this time. We gave Amber several very loud and clear verbal commands to come speak with us. Amber kept her hand on the lock, which made it impossible for us to unlock the door with the key. At some point, Michelle opened the window to the kitchen which was right next to the front door. We were able to make clear commands and able to hear Amber clearly also. We gave Bohdi several commands to run to the back door and go to his dad. Bohdi was able to run away from Amber at one point, making Amber release the lock and chase Bohdi to the back door. While Amber ran to the back, I was able to unlock the top dead bolt with the key, however, when I attempted to open the bottom lock Amber was already back to the front door. I clearly remember hearing Ofc. Perez yelling through the kitchen window at Amber and telling her not to do that to her son. I asked Ofc. Perez what she was doing, and he stated she dragged him from the back door to the front by his arm across the floor. We continued to beg and plead with Amber to just open the door. Please note that at no point did Amber put the pepper spray down and a few times put the pepper spray directly in front of Ofc. Perez face while he was giving Bohdi verbal commands through the open kitchen window. Amber placed herself on the ground in a position where she was sitting against the staircase and had her legs extended all the way out against the front door. It would be impossible to open the door at this point without breaking her legs or seriously injuring her. Amber had Bohdi on top of her and was holding him down so he could not run away from her. Amber finally opened the door on her own but only cracked the door. Amber told us we could have Bohdi but she stayed. While she was screaming this at us, she had the pepper spray pointed directly in Sgt. Dupontys face. Sgt. Duponty made sure Bohdi was safely taken from the home and Ofc. Young took him away from the home. Amber attempted to slam the door shut but Sgt. Duponty was able to push the door open. I drew my taser to hopefully use it to deter Amber from resisting. When Sgt. Duponty pushed the door open, Amber pointed the spray in his face as if she was going to spray him. Sgt. Duponty grabbed Amber and took her down to the ground. While attempting to detain Amber she sprayed Sgt. Duponty and Ofc. Perez directly in the face with the spray. While on the ground she continued to spray the bottle which sprayed me in the face and arms. We all began coughing and gagging and unable to breathe properly. My vision went blurry, and I could not open my eyes. Sgt. Duponty was able to place handcuffs on her. Sgt. Duponty and Ofc. Perez were completely incapacitated as they took direct hits in the face with the pepper spray. Sgt. Duponty and I grabbed Amber off the ground and Ofc. Young and I escorted her to my patrol car. I told Key West Dispatch that we had her in custody and to send rescue as she had sprayed 3 police officers with pepper spray. When we got to my patrol car, Amber began to kick Ofc. Young repeatedly striking her in the arms, legs, face, and chest area. I was able to get ahold of Ambers left leg and I pinned it up against the frame of my patrol car to gain control of legs. Ofc. Young drew her taser and pointed it at

Amber. At this point, Amber immediately stopped resisting and began to comply. Ofc. Perez was able to get a hobble device from his patrol car and we were able to place the hobble around her legs which controlled her from possibly kicking us again.

Key West Fire and Rescue arrived on scene and rendered aid to us officers affected by Amber's use of pepper spray against law enforcement. While in the back of patrol car, Amber began to tell us none of our children were safe and that Jakub was coming for us. Amber stated Jakub is a very dangerous man. I asked Amber if she had pepper spray on her and she stated she did. I grabbed the first firefighter I could see, and he tended to Amber. Amber stayed in the back of my patrol car until she was placed into Ofc. Youngs patrol car and transported to Monroe County Detention Center. My body camera was on during my entire time on scene. Please refer to my body camera to see the erratic and abnormal behavior Amber displayed during our time on scene. Ofc. M Calvert placed the completely empty pepper spray bottle into Key West Police Property and Evidence under this case number. Note Amber sprayed the entire bottle of spray on us.
