ORDER IMPOSING LIEN/ AMENDED FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

This cause having come before the Special Magistrate on April 25, 2018, pursuant to the Florida Statutes Chapter 162 and Article VI et seq of the Key West Code, and the Special Magistrate having heard sworn testimony, having reviewed the evidence submitted, and being otherwise advised of the premises; The Special Magistrate finds Ted J McBrynett Estate is in violation of Key West Code of Ordinances, section(s) 26-126. In that the following condition(s) exists 1007 Thomas Street, Key West, FL: Count 1: For failure to remove debris, garbage and rubbish from the property that has been determined to be a fire hazard.

Accordingly, it is hereby ORDERED:

- Imposed is an Administrative Fee of \$250. Also imposed is a fine of \$250 per day if compliance is not obtained by May 29, 2018. A compliance hearing will be held on May 30, 2018. All fines and fees are payable within thirty (30) days from the date of this order to the City of Key West, Code Compliance Division, PO Box 1409, Key West, FL 33041.
- 2. This Order may be recorded in the official records of Monroe County and shall constitute a lien, pursuant to Florida Statutes Section 162.09 (3), for judgment purposes. This case may serve as a predicate for a repeat violation should similar violations occur in the future at this or any other location in the city.

If you request that the fine be reduced or mitigated, you must be in compliance and you must request in writing to appear before the Special Magistrate two weeks prior to a hearing to show cause why said fine should be mitigated.
