Hi Teri,

Just to add a little to what you received yesterday from Larry.....

The two Board positions were first advertised in the Citizen in March; applications were available to the public March 10th. The openings were advertised again on April 13th. These positions were also talked about on Morning magazine for the same two months as well as during Ambassador class presentations. The last day to receive applications (also advertised) was Friday, May 16th.

Mr. Galvan mistakenly sent his application on May 12th to the wrong email address. I was contacted by Chief Lee on Wednesday, May 28th after the Commission agenda was posted, asking about the omission of Mr. Galvan's application. I explained to him that I'd never received his application. After research on his part he called me back and stated that Mr. Galvan had sent his application to keywestcity.gov or .org and asked if Mr. Galvan could re-send his application, showing he had sent it on May 12th, and get it on the agenda. I told him that I didn't think it was possible since the agenda was already posted but maybe ask Cheri Smith. Mr. Galvan did indeed re-send his application to the CRB and Larry responded to him explaining the situation and pointing out that the application was incomplete as several questions were not answered.

The CRB has a Board position that may or may not be opening as Kevin Collins' term expires on June 30th. He has not yet said whether he will be seeking re-appointment. The two current vacancies (Commission appointments) leave the CRB with only four Board members and barely a quorum. This leaves the Board in a precarious position if the decision is postponed past this next meeting.

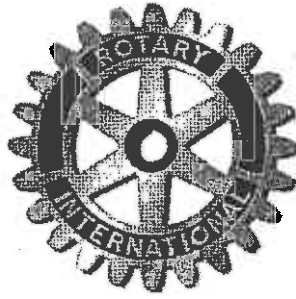
