A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) UNMARKED FORD POLICE INTERCEPTOR SEDAN (\$26,212.55) FROM GARBER FLEET SALES, ONE (1) FORD TRANSIT T-350 CARGO VAN (\$27,650.00) FROM DON REID FORD AND THREE (3) FORD F-250XL 4WD DIESEL CREW CAB PICKUP TRUCKS (\$41,447.00 EACH/TOTAL OF \$124,341.00) FROM DUVAL FORD FLEET SALES, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES IN THE TOTAL AMOUNT OF \$178,203.55 FOR USE BY THE KEY WEST POLICE DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase is pursuant to section 2-797(3) of the Code of Ordinances;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a total of five (5) vehicles, pursuant to the attached proposals of Garber Fleet Sales (one unmarked Ford Interceptor sedan - \$26,212.55), Don Reid Ford (one Ford Transit T-350 Cargo Van (\$27,650.00), and Duval Ford Fleet Sales (three unmarked Ford F-250XL 4WD Crew Cab Pickup Trucks - \$124,341.00), pursuant to section 2-797(3) of the Code of Ordinances, in the total amount of \$178,203.55 is hereby authorized.

Section 2: That this Resolution shall go into effect immediately upon its passage, adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
