Description of Work:

Construction of a new one and a half-story frame house with pool and deck on a vacant lot.

Site Facts:

The site under review is a vacant lot. Formerly identified as 519-521 Margaret Street, the parcel previously consisted of two dwellings as shown on the 1912, 1926, and 1948 Sanborn Maps for 519 and 521 Margaret Street. The 1962 Sanborn Map only indicates one dwelling on what was then 521 Margaret Street. By 1965, there is no indication of either property in the Polk City Directory. Further, there is no record of a survey or designation of either property prior to the Key West Historic District designation in 1971.

In 2003 and again in 2009 various boundary changes were made to these properties in order to allow adjacent properties to become more compliant with dimensional code requirements. In 2009, these parcels were combined to form one parcel.

Guidelines Cited on Review:

- New construction (pages 38a 38q), specifically guideline 2 on page 38c, and guidelines 1, 2, 3, 6, 7, 8, 9, 11, 12, 13, 14, 15, 17, 18, 22, 23, and 24.
- Decks, pools (page 39a), specifically first paragraph and guideline 3.
- Air conditioning units (pages 42 43), specifically guideline 5.
- Parking areas, landscaping, and open space environment (page 43), specifically first paragraph and guidelines 1, 2, 4, 5, and 6.

As the application proposes new construction on a vacant lot, the *Evaluation by Guidelines* (pages 38p - 38q) are included:

(1) Does the new building or structure have a similar height to the immediately adjacent buildings?

No. The home to the south of the proposed two-story house is an eyebrow house and roughly 2' shorter in height. The home to the north is a single-story cottage and roughly 10' shorter in height.

(2) Is the new building or structure sensitive and harmonious to the immediate urban context in which it will be located?

No. This lot size is atypically large for this block and neighborhood. While the architect has designed the house within the required setbacks,

the overall size, mass, scale, roof design, and level of detailing incorporated in the porch breaks the harmony of the immediate context.

(3) The new building or structure does not parody any existing building within the urban block.

No, this is not the case however, the new house appears to replicate a unique historic house located at 520 Angela Street.

(4) The new building or structure does not overpower adjacent buildings or structures.

Yes. The new house is much larger in size, mass, and scale than adjacent homes or most on this block. The roof design, specifically the front gable is foreign to the urban context.

(5) Does the new building or structure maintain the required setbacks and relationship to the street and or site.

Yes, this is the case.

(6) For new buildings or structures facing a street, does any façade facing a street maintain similar rhythm, and composition found in adjacent buildings and or same typology?

No. While the general character of this home is fitting in Key West however, the overall mass and scale of this house will likely alter the rhythm of the street.

(7) The new design does not propose a carport or garage that is visible from any street?

No, this is not the case.

(8) Does the new building or structure have a similar scale, mass, and form to the buildings immediately adjacent to where it will be built?

No, the scale, roof design, and mass of the house is significantly larger than the immediately adjacent homes.

(9) Are the exterior materials for the new building or structure similar to those used on the immediate adjacent properties or same typology?

Yes, exterior materials are fitting within the seen on adjacent homes.

(10) The new building or structure does not include elements such as roof decks, balconies, dormers, roof forms, openings, doors, and windows, among others, that are incompatible or would unnecessarily intrude on the privacy of the immediate adjacent buildings or structures?

Yes, the house incorporates roof forms that, while appropriate in general form, are much larger and incompatible with immediately adjacent homes.

Staff Analysis:

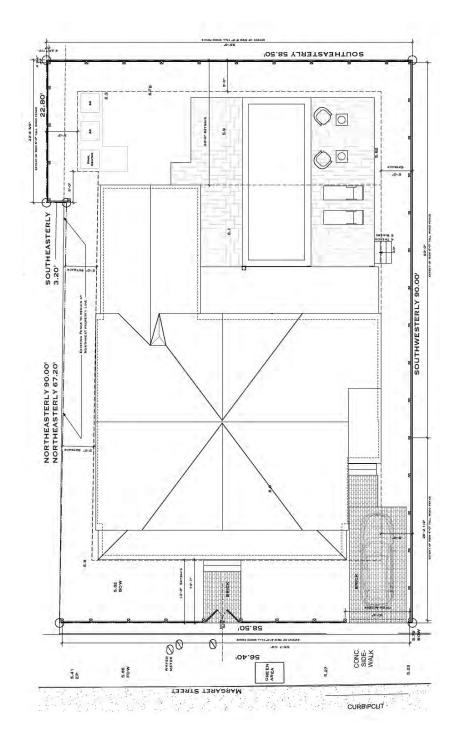
The Certificate of Appropriateness is under review proposes the construction of a new one and half-story wood frame house, pool, and deck on the vacant parcel.

The new Carpenter Gothic influenced house features a centered gable front facing design with five bay front porch and central entryway to the house. A portion of the side gabled structure and side porch will protrude on the southeast side of the main structure and be visible from the street. This protrusion will provide side-yard access to parking.

The parcel, formerly two lots, provides a wider frontage than many of the nearby lots. The new house is subsequently significantly wider than many of the nearby houses. While the roof form variation, front porch, and recessed side protrusion help to reduce the overall scale and mass of the house, it remains a much larger structure than the immediately adjacent homes and blocks. The front porch elevation and height of first and second floor windows is consistent with nearby homes. The second floor, in particular the overall height and mass of the roof plane are exaggerated in contrast to adjacent homes. The approximate height from the first-floor plate height (ceiling of first-floor) to the roofline is approximately 17.5', or nearly two-stories. The new structure complies with current setbacks.

The house will have horizontal composite lap siding, impact wood entry and side doors, and impact wood windows. Doors located at the rear of the house will be impact aluminum. The roof of the structure and porch will be pressed metal shingles, and the front porch will include a decorative balustrade and substantial decorative trim and brackets at the porch columns. Additional decorative wood detailing will be at the front and rear gables.

Site features will include a brick single space parking pad and brick sidewalks at the front of the house, and a pool with surrounding stone pool deck at the rear of the structure. The pool and pool deck will be elevated approximately 2'-4" to be generally flush with the finished floor elevation of the house and not be visible from the street. Pool and AC equipment will be located at the rear of the structure and may be visible from the street unless screening is provided by a wood fence that is proposed to be included on a separate permit.

Consistency with Guidelines Cited Guidelines:

It is the staff's opinion that the proposed design for Certificate of Appropriateness H2023-0043 does not conform with cited guidelines. While the general design and style of the house are appropriate for Key West and this location, the overall second-story height and roof plane mass are substantially greater than the immediately adjacent homes and block. Additionally, the level of detail or gingerbread on the front porch is much more elaborate than would typically be seen on this or adjacent blocks. It is staff's opinion however, that a simplified front porch, and reduced height of the second-story, particularly the roof above second floor plate height, may result in a more scale appropriate house that is compatible within the block.

It is further noted that this house appears to be a near replica to the design seen in 520 Angela Street, a unique structure built c. 1889. This is conflictive with guideline 3, as it may create a false sense of history.

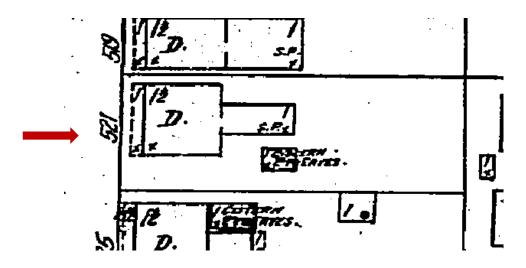

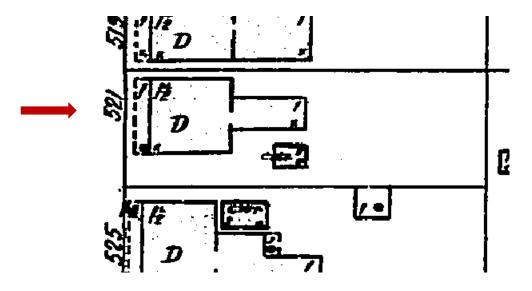

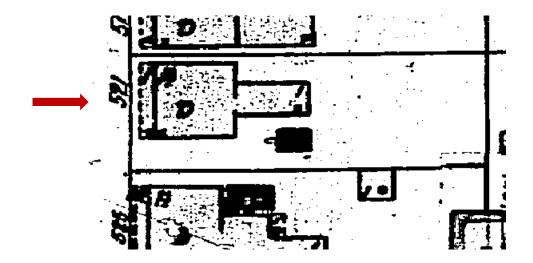
Sanborn Maps 521 Margaret Street



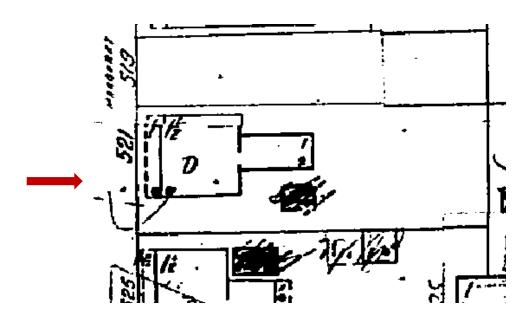
1912 Sanborn Map



1926 Sanborn Map



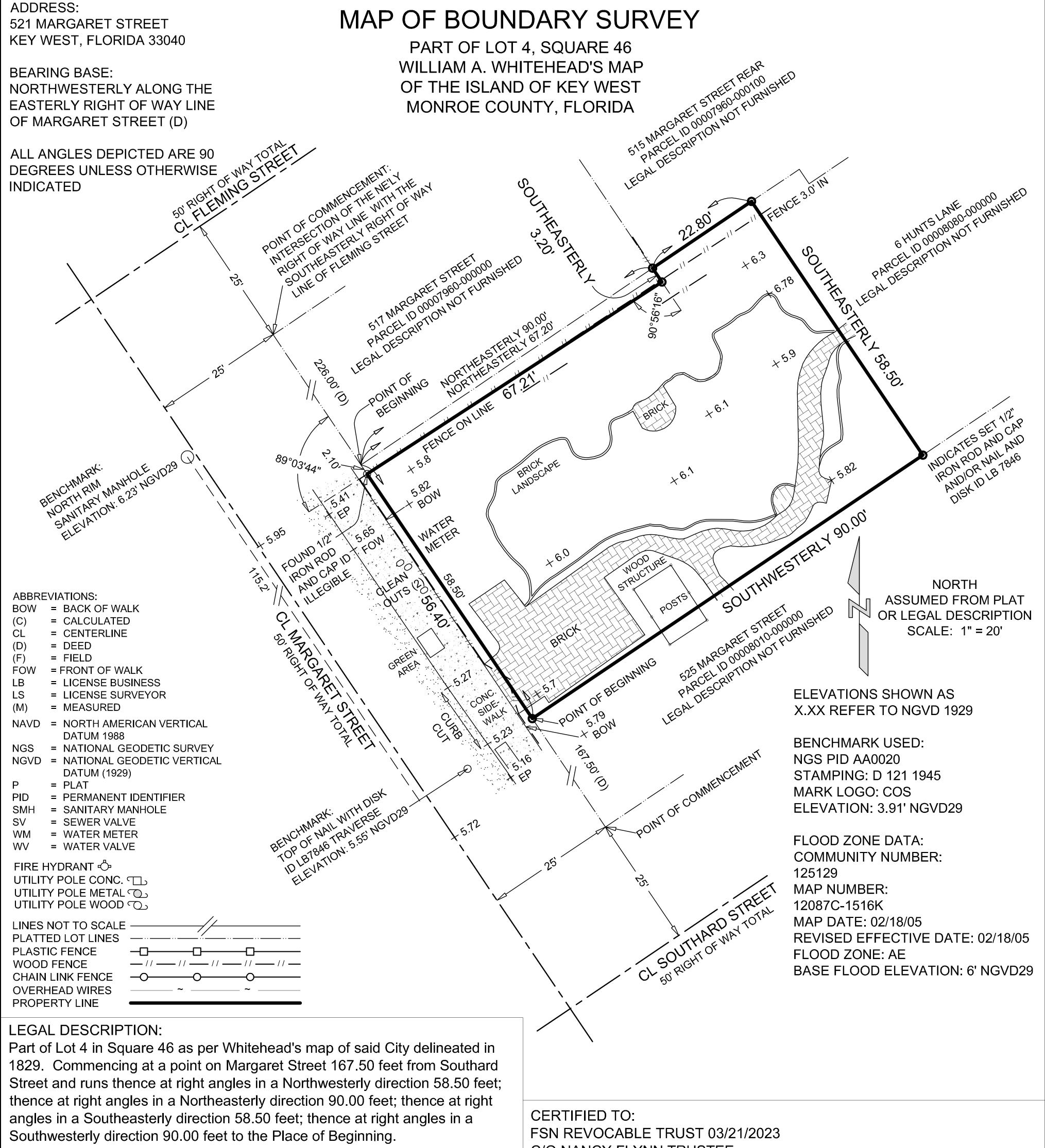
1948 Sanborn Map

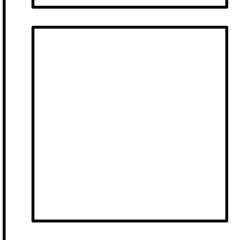

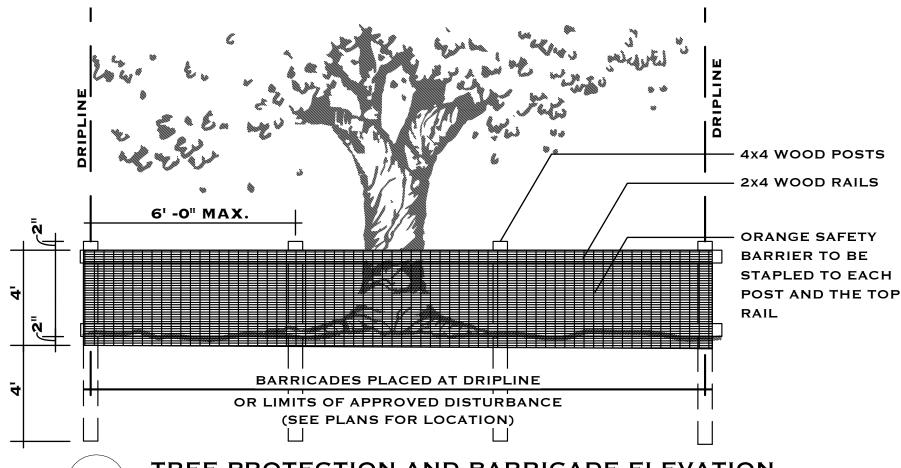
This letter is in response to a request for build back approval received by the Planning Department on May 9, 2022, for property formerly identified as 519-521 Margaret Street, Key West, FL 33040, parcel #00007990-000000. The subject property was combined with 525 Margaret Street at the request of the property owner in 2009; the city now recognizes the property as 525 Margaret Street, parcel #00008010-000000. The parcel is located within the Historic High Density Residential (HHDR) zoning district, which is regulated by Chapter 122, Article IV, Division 6, Subdivision IV of the City of Key West Land Development Regulations.

The Sanborn Maps dated 1912, 1926, and 1948 indicate two structures addressed 519 and 521 Margaret Street located on the parcel, both of which are labeled "D" meaning dwelling units. The Sanborn Map dated 1961 indicates one structure, 521 Margaret Street, remaining on the property. By 1965, Polk City Directory does not indicate a record for either property.

Section 122-26. states "Noncomplying building or structure means any building or other structure, for which the use is lawful (permitted or nonconforming), but the building or other structure does not comply with all applicable sections of the land development regulations, including, but not limited to, size and dimension regulations, off-street parking requirements, landscape requirements, nuisance abatement standards, or height requirements, either on the effective date of the ordinance from which this section derives or as a result of any subsequent amendment."

Both structures were demolished prior to the effective date of Ordinance 00-10, which was passed in June 2000. Furthermore, according to our Historic Preservationist, there was no historic designation or survey performed to support the historic district designation prior to 1971, therefore the structure could not be considered as contributing to the historic district.

Based upon our findings, we are unable to authorize a build-back letter allowing for reconstruction of noncomplying units, but we have verified the existence of two dwelling units on the property. Any proposed development will be subject to HARC guidelines, in addition to the current Land Development Regulations
