**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES TO THE FLORIDA POWERBOAT CLUB, INC. FOR AN EVENT TO TAKE PLACE DURING THE HOURS OF 8:00 P.M. TO 11:00 P.M. ON FRIDAY , NOVEMBER 12 & SATURDAY, NOVEMBER 13, 2010 AT THE CONCH REPUBLIC SEAFOOD COMPANY; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Section 6-86 of the Key West Code of Ordinances requires a Special Event Permit to depart from the requirements of the City's Noise-Control Ordinance; and

**WHEREAS**, the Florida Powerboat Club has applied to the City for a Special Event Permit for "Key West Offshore Poker Run" on Friday & Saturday, November 12 & 13, 2010; and

**WHEREAS**, this event shall take place on the grounds of the Conch Republic Seafood Company at 631 Greene Street between the hours of 8:00 p.m. and 11:00 p.m.; and

**WHEREAS**, amplified music will be played during the event;

**NOW THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida:

**SECTION 1.** That Florida Powerboat Club is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time as herein described.

**SECTION 2.** That the Florida Powerboat Club will adhere to the recycling plan of the City of Key West.

**SECTION 3.** That this Resolution shall go into effect immediately upon its passage and

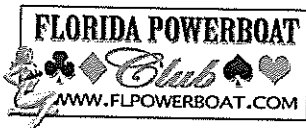

Our application fee of \$50 has been enclosed with the application.

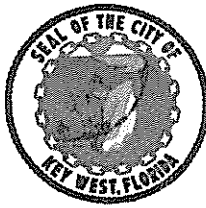
If you have any questions at all, please contact me at the address or phone numbers listed above.
