Section 3: Personnel Qualifications and Availability

Omar Franco will serve as primary point of contact for our representation for the City of Key West. Section 4: Implementation of Scope of Services

Working in consultation with the City Manager and/or his designee, Becker & Poliakoff (B&P) will work closely with the City to obtain all necessary project information. We will work to secure federal funding for the City including proactive identification of specific funding opportunities and will monitor federal legislation and programs of federal agencies to identify new funding sources. We will also prioritize funding opportunities according to their potential as funding sources for the city. B&P will then develop time lines giving dates when certain activities should begin, or when materials should be compiled, to meet Federal guidelines and deadlines.

B& P will act as the representative of the City and its projects and we will coordinate with the County and State Congressional Delegation in gaining support for federal funding for the City as well as assist in drafting appropriate correspondence, schedule briefings and meetings. We will then identify and meet with key federal agencies, officers of the federal government and members of Congress related to specific funding sources; propose and implement lobbying and advocacy strategies for gaining their support for City projects. We will establish and maintain liaisons with key federal agencies and officers, and elected officials to gain support for City projects and if requested, prepare federal grant applications.

B&P plans to provide technical assistance and guidance to City staff in preparing correspondence and reports for Federal funding contacts and, as requested or necessary, arrange meetings between federal agencies and members of Congress and the Mayor, City Commission Members and the City Manager to promote the funding of City projects or to discuss legislative issues affecting the City. We shall also identify agencies or local governments which may be competing for specific grants or appropriations, and help align support for City projects.

B& P is prepared to provide quarterly reports to the City Manager demonstrating the progress of the firm toward securing funding for City projects. The report shall provide sufficient information as needed in order for the City Commission, City Manager and staff to support any lobbying strategies. We will also appear before the City Commission as requested to report on funding development activities, approximately two times annually. Appearances will be scheduled in advance at the request of the Commission.

Therefore, we propose the following goals and tasks to provide the best service to City of Key West:

GOAL 1: Effectively develop funding initiatives, inclusive of annual appropriations requests and agency specific grant opportunities for City.



Strategic development is critical to any successful lobbying effort -- planning, coordinating and executing strategies to achieve the policy goals. We will work with the City to re-examine its current government affairs plan and, if chosen, would recommend an in-depth strategy session among all the team members and the City as soon as possible. We will:

TASK 1

- a) Meet with all senior leadership at the City to analyze the current federal appropriations requests, and conduct strategic long-term analysis for future requests.
- b) Assist the City in development, drafting and submission of appropriation requests and all the supporting documentation to the Congressional offices.
- c) Meet with the Congressional offices and the representatives of the City to introduce the 2013 legislative agenda.

TASK 2

- a) Attend Congressional hearings and markups on appropriations in the U.S. House and U.S. Senate.
- b) Coordinate meetings between City representatives and the leadership in the U.S. House and U.S. Senate Appropriations Committee members.
- c) Identify and meet with Executive Branch officials to discuss alternative funding opportunities for City projects through the Executive Branch and target the following agencies for funding opportunities: Department of Energy, Department of Agriculture, Department of the Interior, Department of Commerce, and Department of Homeland Security, among others.

TASK 3

- a) Develop and execute a strategy to ensure that City projects are included in the preliminary bills in both the U.S. House and U.S. Senate.
- b) Encourage City representatives to initiate a second round of meetings with the City delegation members and key Appropriation leadership members.

TASK 4

a) Develop a strategy to ensure that every project funded in the preliminary bills makes it into final conference reports.



These are just a few examples of areas through which we believe the City could pursue federal funding.

- GOAL 2: Establish and maintain liaison services, establish regular interaction, and assist the City in building their influence with the entire U.S. Congress, and the Florida Congressional Delegation.
- <u>TASK 1:</u> Work to identify public policy issues of importance to the City and develop specific position papers on each issue area, working with the government relations team and leadership at the City. These issue papers will be updated on a regular, and as warranted, basis.
- <u>TASK 2:</u> Present the revised agenda to the Congressional Delegation and as appropriate, advance components of the agenda with members of the U.S. House and the U.S. Senate with legislative jurisdiction over targeted issues.
- <u>TASK 3:</u> Coordinate site visits by Congressional members, specifically the local Congressional Delegation, to the City to enhance the visibility and recognition of City's exemplary projects.
- <u>TASK 4:</u> Identify opportunities for the City leadership to testify before Congress on issues of importance and priority.
- <u>TASK 5:</u> Identify specific actions to be appropriately advanced that will enhance the City's relationships with the Congressional Delegation members and their staff.
- <u>TASK 6:</u> Establish relationships with Appropriations Committee members of the U.S. House and U.S. Senate outside of Florida, including their key staffers.
- <u>TASK 7:</u> Assist with the management of visits/fly-ins of City representatives to Washington, D.C. for the purpose of meeting with members of Congress and their appropriations staff.
- <u>TASK 8:</u> Coordinate and accompany site visits by Appropriations members and staff to the City to enhance the visibility and recognition of City's exemplary projects.
- GOAL 3: Establish and maintain liaison services, establish regular interaction, and assist the City in establishing long-term relationships with the Executive Branch agencies.

It is important that the federal agencies be familiar with and feel comfortable calling upon the City at both the political appointee and career service levels. As



part of our efforts on behalf of the City, we will establish and maintain relationships with the new key policymakers. We will:

<u>TASK 1:</u> Set up and coordinate meetings on behalf of the City with the Obama Administration to communicate the City's perspectives on new policy initiatives for the 112th Congress as it will be important for the City to establish a relationship with the Administration leadership.

<u>TASK 2:</u> Advance relationships in these key departments/agencies including:

Section 5: Fees

In consideration of the foregoing federal lobbyist services, the City of Key West would agree to pay Becker & Poliakoff, P.A. \$4,000 per month. Becker & Poliakoff, P.A., if selected, agrees to sign a formal agreement in the standard form currently used by the City of Key West for professional services.

Any expenses incurred by the B&P in the representation of the City of Key West will be included in the monthly retainer. These will include meals, local transportation, lodging, business expenses, messenger and long distance services. Travel outside of the Washington, D.C. metropolitan area will be reimbursed only if authorized <u>in advance</u> by the City of Key West.

The cost basis of this RFP is derived from our years of experience in working with other municipalities and an estimate of how many hours will be required to successfully perform the scope of service.

In addition, B&P is also available to provide other legal services from customs and international trade, corporate and securities, business litigation, to real estate and other specialized areas. Of course such services are not within the scope of our lobbying efforts and would be subject to separate retainer.
