A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Wednesday, January 22, 2014.

Mayor Craig Cates called the meeting to order at 6:00 p.m.

City Attorney's Report

City Manager Vitas spoke of the new program for Employee Performance Evaluations for employees. He discussed the Directors will have training on the process of evaluations and to tie those

evaluations in with the Anniversary date of the employee and then have the evaluation filtered in to the Fiscal Year.
