A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTION 2-797(3) AND (4)(b) OF THE CODE OF ORDINANCES, THE PROCUREMENT OF AUDIO/VISUAL/INFORMATION TECHNOLOGY UPGRADES TO CITY COMMISSION CHAMBERS FROM AVI-SPL LLC IN AN AMOUNT NOT TO EXCEED \$133,970.24 THROUGH THE INTERLOCAL PURCHASING SYSTEM - A DEPARTMENT OF EDUCATION SERVICE CENTER REGION 8 - A TEXAS GOVERNMENTAL ENTITY CONTRACT RFP 200904 ("TIPS"); AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contract; and

WHEREAS, staff finds AVI-SPL LLC, as assignee for TIPS contract holder Audio Visual Innovations, provided a reasonable and responsive price quote; and

WHEREAS, purchases under government purchasing cooperative programs are authorized pursuant to Section 2-797(3), and the City Manager has determined that the procurement, including equipment and installation, of certain audio/video/information technology equipment from AVI-SPL LLC, as described in the attached price quote, is in the best interests of the City pursuant to section 2-797(4)(b) of the Code of Ordinances; and

WHEREAS, as part of the American Rescue Plan Act (ARPA), the City received funding through the Florida Division of Emergency Management (Resolution 21-191, Agreement No. Y5151) for financial assistance supporting critical infrastructure, including the AVI-SPL LLC audio/visual/information technology equipment upgrade in Commission Chambers; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the procurement of City Commission Chamber equipment upgrades, as described in the attached price quote, in a total amount not to exceed \$133,970.24, from AVI-SPL LLC is hereby approved, through the TIPS Contract No. 200904, pursuant to Section 2-797(3) of the Code of Ordinances, and in the best interests of the City, pursuant to Section 2-797(4)(b).

Section 2: It is anticipated that the cost of this purchase will be covered by ARPA grant funding. The purchase, in an amount not to exceed \$133,970.24, will be paid from budget account number 001-1303-513-6400, and any necessary budget transfers and amendments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents upon consent of the City Attorney. Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
