**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE KEY WEST GATOR CLUB AS AN AFFLIATE OF THE UNIVERSITY OF FLORIDA ALUMNI ASSOCIATION TO CONDUCT A FULL AND ½ MARATHON ON SATURDAY, OCTOBER 10, 2015 FROM 5:30 A.M. TO 2:00 P.M. AUTHORIZING THE CLOSURE OF FRONT STREET FROM DUVAL STREET TO SIMONTON STREET INCLUDING THE SIMONTON STREET BEACH AREA; AUTHORIZING CERTAIN STREET CLOSURES THEREOF DURING THE EVENT; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCES FROM 5:30 A.M. TO 2:00 P.M.; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER;; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** Permission is hereby granted to the Key West Gator Club to conduct a Marathon & ½ Marathon on Saturday, October 10, 2015.

**NOW, THEREFORE, BE IT RESOLVED,** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That permission is hereby granted to the Key West Gator Club as an affiliate of the University of Florida Alumni Association to conduct a Marathon and ½ Marathon on the date and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the City is excuted; and that the organizing meet the terms

**SECTION 2.** That the Key West Gator Club as an affiliate of the University of Florida Alumni Association is hereby granted permission for the closure of certain streets throughout the City for a Marathon & Half Marathon on the date and during the hours stated above.

**SECTION 3.** That the Key West Gator Club as an affiliate of the University of Florida Alumni Association is hereby granted a Special Event Permit under Section 6-86 of the Code of Ordinances for an event that will take place and time herein described.

**SECTION 4.** That pursuant to Section 18-86 of the Code of Ordinances, Key West Gator Club is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 5.** That the Key West Gator Club as an affiliate of the University of Florida Alumni Association will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
