DESCRIPTION:

Add Solar System to Project

Design Assist, Furnish and Installation of a fully functional roof mounted solar photovoltaic electrical generation and distribution system complete utilizing micro inverters to split solar between building panels PP and TP in accordance with SALT Energy Updated Proposal dated December 19, 2023 and Frederick Douglass Solar Project Option 2. System shall include, but is not limited to, all required design assist details and collaboration with the Design Consultants, engineering, structural framing & supports, attachments to the roof, photovoltaic panels, equipment/controllers/meters/disconnects/switchgear/invertors & devices/data monitoring system, conduit, and wiring for a complete, turnkey, and fully operational system. This change order also includes upgrade of Main Hall roof to GAF Everguard Extreme TPO with a 30 year warranty.

Additional Secondary Feeder Footage and Generator Breaker

Provide two (2) new breakers in new generator in lieu of the original one (1) breaker to allow the generator to power both the new Community Center and the existing Gymnasium. Reroute conduits and conductors from existing ATS in the gymnasium electrical room to the new generator location, make all terminations inside new generator and test all connections.

Provide all labor, material, excavation, backfill, etc. as required for additional secondary electrical footage required due to Keys Energy eliminating pad mount transformer as originally designed and changing to pole mounted transformers in southwest corner of the site.

Utilize project utility allowance to cover the secondary feeder and generator breaker costs.

Please note that we have included no additional time within this change order and reserve our rights as to how these changes impact project schedule.
