A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ACCEPTING NEGOTIATED AND EXECUTED CONTRACT BETWEEN THE CITY OF KEY WEST AND STANTEC CONSULTING SERVICES FOR THE DUVAL STREET ECONOMIC CORRIDOR RESILIENCY AND REVITALIZATION IN THE AMOUNT OF PLAN \$830,918.00; APPROVING ANY NECESSARY AMENDMENT AND TRANSFERS; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, in Resolution 22-144, the City Commission approved the "State of Florida Department of Economic Opportunity Federally Funded Community Development Block Grant Mitigation Program (CDBG-MIT) Subrecipient Agreement" #MT011 for the Duval Street Economic Corridor Resiliency and Revitalization Plan, accepting a total amount up to \$500,000.00 (city match of up to \$565,310.00); and

WHEREAS, in Resolution 22-256, the City Commission approved the ranking of proposals in response to RFQ 22-004 and authorized the City Manager and City Attorney to negotiate and execute a contract with the highest ranked firm, Stantec Consulting Services, Inc., to provide complete services for the revitalization of the Duval Street historic corridor. These services are further described in the RFQ under Section B, Scope of Work/Service; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached negotiated and executed contract between the City of Key West and Stantec Consulting Services, Inc. for the Duval Street Economic Corridor Resiliency and Revitalization Plan is hereby accepted and approved in an amount of \$830,918 in accordance with RFQ 22-144.

Section 2: That the City Manager or his designee is hereby authorized to execute any necessary documents, in conformance with terms and conditions contained in the RFQ and the Contract, upon the advice and consent of the City Attorney.

Section 3: That this contract will be funded from 101 1900 519 6300 (Infrastructure), Project Number IS19002102 and any necessary budget adjustments are hereby authorized.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
