**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AUTHORIZING THE PURCHASE OF ONE (1) 2026 F-150 CREW CAB XLT SERVICE VEHICLE WITH ACCESSORIES FROM TROPICAL FORD FOR USE BY THE CITY'S DEPARTMENT OF TRANSPORTATION IN AN AMOUNT NOT TO EXCEED \$70,000 TO BE PURCHASED AND FULLY FUNDED THROUGH FLORIDA STATE PURCHASING CONTRACT #25100000-23-STC, PURSUANT TO SEC. 2-797(3) OF THE CODE OF ORDINANCES OF THE CITY OF KEY WEST, FLORIDA; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY RELATED DOCUMENTS, BUDGET TRANSFERS AND/OR ADJUSTMENTS, UPON CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, on June 6, 2024 the City Commission passed Resolution 24-129 approving the Public Transportation Grant Agreement between the Florida Department of Transportation and the City of Key West for SFY 2024 FTA section 5339 Rural Bus and Bus Facility Capital Funds in an amount not to exceed \$70,000 to provide capital assistance for the purchase of support equipment for buses and transit facilities; and

WHEREAS, on November 5, 2025, the City Commission passed Resolution 25-330 to extend the expiration of the grant funding period to October 1, 2026, and also change the scope from the purchase of one vehicle (a van) to "up to two (2) vehicles"; and

WHEREAS, Sec. 2-797(3) of the City's Code of Ordinances, provides an exemption to the competitive/sealed bidding or competitive request for proposals for "Purchases and

*acquisitions under contracts of federal government, the state or its political subdivisions and governmental purchasing cooperative programs.;" and*

WHEREAS, pursuant to Sec. 2-797(3) of the City's Code of Ordinances, the purchase of this service vehicle from Tropical Ford for use by the City's Transit Department in an amount not to exceed \$70,000 will be funded 100% through State Contract #25100000-23-STC;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby approves the purchase of one (1) 2026 F-150 Crew Cab XLT service vehicle with accessories from Tropical Ford for use by the City's Department of Transportation in an amount not to exceed \$70,000.00 to be purchased and fully funded through Florida State Purchasing Contract #25100000-23-STC, in accordance with Sec. 2-797(3) of the City's Code of Ordinances.

Section 2: That the City Manager is hereby authorized to execute any necessary related documents, budget transfers and/or adjustments, upon advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
